6 AS INTRODUCED

7 An Act relating to higher education; creating the
8 Legislative Accountability Act; providing for
9 establishment of certain tuition and fee amounts by
10 the Oklahoma Legislature; repealing 70 O.S. 2001,
11 Sections 3218.2, as amended by Section 1, Chapter 4,
12 O.S.L. 2003, 3218.8, as last amended by Section 1,
13 Chapter 53, O.S.L. 2008 and 3218.9, as amended by
14 Section 3, Chapter 4, O.S.L. 2003 (70 O.S. Supp.
15 2008, Sections 3218.2, 3218.8 and 3218.9), which
16 relate to establishment of tuition and fees by
17 Oklahoma State Regents for Higher Education;
18 providing for codification; providing for
19 noncodification; and providing an effective date.

22 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

23 SECTION 1. NEW LAW A new section of law not to be
24 codified in the Oklahoma Statutes reads as follows:

25 This act shall be known and may be cited as the "Legislative
26 Accountability Act".

27 SECTION 2. NEW LAW A new section of law to be codified
28 in the Oklahoma Statutes as Section 3218.16 of Title 70, unless
29 there is created a duplication in numbering, reads as follows:

1 Resident tuition, nonresident tuition, and other fees to be
2 required of students receiving instruction or other academic
3 services provided by institutions of The Oklahoma State System of
4 Higher Education shall be established by the Oklahoma Legislature
5 beginning with the 2010-2011 academic year.

6 SECTION 3. REPEALER 70 O.S. 2001, Section 3218.2, as
7 amended by Section 1, Chapter 4, O.S.L. 2003 (70 O.S. Supp. 2008,
8 Section 3218.2), is hereby repealed.

9 SECTION 4. REPEALER 70 O.S. 2001, Section 3218.8, as
10 last amended by Section 1, Chapter 53, O.S.L. 2008 (70 O.S. Supp.
11 2008, Section 3218.8), is hereby repealed.

12 SECTION 5. REPEALER 70 O.S. 2001, Section 3218.9, as
13 amended by Section 3, Chapter 4, O.S.L. 2003 (70 O.S. Supp. 2008,
14 Section 3218.9), is hereby repealed.

15 SECTION 6. This act shall become effective July 1, 2010.
