BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 EDUCATION

2 SECTION 1. There is hereby appropriated to the Oklahoma Arts
3 Council from any monies not otherwise appropriated from the General
4 Revenue Fund of the State Treasury for the fiscal year ending June
5 30, 2011, the sum of _____ Dollars (\$0.00) or so much thereof
6 as may be necessary to perform the duties imposed upon the Oklahoma
7 Arts Council by law.

8 SECTION 2. There is hereby appropriated to the State Board of
9 Career and Technology Education from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2011, the sum of _____ Dollars
12 (\$0.00) or so much thereof as may be necessary to perform the duties
13 imposed upon the State Board of Career and Technology Education by
14 law.

15 SECTION 3. There is hereby appropriated to the State Board of
16 Career and Technology Education from monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2011, the sum of _____ Dollars
19 (\$0.00) or so much thereof as may be necessary for the Certified
20 Employee Health Benefit Allowance.

21 SECTION 4. There is hereby appropriated to the State Board of
22 Career and Technology Education from monies not otherwise
23 appropriated from the General Revenue Fund of the State Treasury for
24 the fiscal year ending June 30, 2011, the sum of _____ Dollars

1 (\$0.00) or so much thereof as may be necessary for the Support
2 Personnel Health Benefit Allowance.

3 SECTION 5. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2011, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary for the financial support of public
8 schools.

9 SECTION 6. The State Board of Education is hereby authorized to
10 expend during the fiscal year ending June 30, 2011, from the
11 Education Reform Revolving Fund created in Section 34.89 of Title 62
12 of the Oklahoma Statutes, the sum of _____ Dollars (\$0.00) or
13 so much thereof as may be necessary for the financial support of
14 public schools.

15 SECTION 7. There is hereby appropriated to the State Board of
16 Education from the Oklahoma Education Lottery Trust Fund of the
17 State Treasury for the fiscal year ending June 30, 2011, the sum of
18 _____ Dollars (\$0.00) or so much thereof as may be necessary for
19 the financial support of public schools.

20 SECTION 8. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Mineral Leasing Fund of the State Treasury for the fiscal year
23 ending June 30, 2011, the sum of _____ Dollars (\$0.00) or so

1 much thereof as may be necessary for the financial support of public
2 schools.

3 SECTION 9. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Mineral Leasing Fund of the State Treasury for the fiscal year

7 much thereof as may be necessary for the financial support of public
8 schools.

9 SECTION 10. The State Board of Education is hereby authorized
10 to expend during the fiscal year ending June 30, 2011, from the
11 Common Education Technology Revolving Fund of the State Treasury,
12 the sum of _____ Dollars (\$0.00) or so much thereof as may be
13 necessary for the financial support of public schools.

14 SECTION 11. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 Oklahoma Education Lottery Trust Fund of the State Treasury for the
17 fiscal year ending June 30, 2011, the sum of _____ Dollars
18 (\$0.00) or so much thereof as may be necessary for transfer to the
19 School Consolidation Assistance Fund.

20 SECTION 12. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the
23 fiscal year ending June 30, 2011, the sum of _____ Dollars

11 SECTION 21. The Oklahoma State Regents for Higher Education are

15 (\$0.00) or so much thereof as may be necessary to perform the duties
16 imposed upon the Oklahoma Scenic Rivers Commission by law.
