6 AS INTRODUCED

7 An Act relating to poor persons; amending Section 5,
8 Chapter 315, O.S.L. 2006 (56 O.S. Supp. 2009, Section
9 1011.5), which relates to the incentive reimbursement
10 rate plan for nursing facilities; requiring that the
Oklahoma Health Care Authority make certain
improvements to the plan; and providing an effective
date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY Section 5, Chapter 315, O.S.L.
15 2006 (56 O.S. Supp. 2009, Section 1011.5), is amended to read as
16 follows:

17 Section 1011.5 A. The Oklahoma Health Care Authority in
18 cooperation with the State Department of Health, a statewide
19 organization of the elderly, representatives of the Health and Human
20 Services Interagency Task Force on long-term care, and
21 representatives of both statewide associations of nursing facility
22 operators shall develop an incentive reimbursement rate plan for
23 nursing facilities that shall include, but may not be limited to,
24 the following:

- 1 1. Quality of life indicators that relate to total management
2 initiatives;
- 3 2. Quality of care indicators;
- 4 3. Family and resident satisfaction survey results;
- 5 4. State Department of Health survey results;
- 6 5. Employee satisfaction survey results;
- 7 6. CNA training and education requirements;
- 8 7. Patient acuity level;
- 9 8. Direct care expenditures pursuant to subparagraph e of
10 paragraph 2 of subsection I of Section 1-1925.2 of Title 63 of the
11 Oklahoma Statutes; and

12 9. Other incentives which include, without limitation,
13 participation in quality initiative activities performed and/or
14 recommended by the Oklahoma Foundation for Medical Quality in
15 capital improvements, in-service education of direct staff, and
16 procurement of reasonable amounts of liability insurance.

17 B. The Oklahoma Health Care Authority shall negotiate with the
18 Centers for Medicare and Medicaid Services to include the authority
19 to base provider reimbursement rates for nursing facilities on the
20 criteria specified in subsection A of this section.

21 C. The Oklahoma Health Care Authority shall make improvements
22 to the incentive reimbursement plan to ensure transparency and
23 integrity. These improvements shall include a rankings system to be
24 implemented in a state-federal alliance, and shall measure

1 eligibility for bonus dollars relative to evidence-based criteria
2 for excellent performance in delivery of quality care.

3 SECTION 2. This act shall become effective November 1, 2010.
