7 An Act relating to public health and safety; creating
8 the Oklahoma Methamphetamine Offender Registry Act;
9 creating registry of persons convicted of certain
10 crimes; prohibiting registered persons from
11 purchasing or possessing Schedule V compounds and
12 certain precursors; making registry available to
13 certain persons; stating information to be included
14 on registry; directing court clerks to forward
15 certain conviction information; providing process for
16 removal of name from registry; making certain acts
17 unlawful; providing penalties; providing for
18 codification; providing for noncodification; and
19 providing an effective date.

1 A. There is hereby created within the Oklahoma State Bureau of
2 Narcotics and Dangerous Drugs Control a registry of persons who have
3 been convicted, whether upon a plea of guilty or upon a plea of nolo
4 contendere, or received a suspended sentence or any probationary
5 term, including a deferred judgment, for the crime of possession of
6 methamphetamines or possession of a precursor with the intent to
7 manufacture methamphetamine. Any person subject to this registry
8 shall be prohibited from purchasing, possessing or having control of
9 any Schedule V compound, mixture, or preparation containing any
10 detectable quantity of pseudoephedrine, its salts or optical
11 isomers, or salts of optical isomers.

12 B. The registry shall be maintained by the Bureau. The
13 registry shall be made available for registrants who sell
14 pseudoephedrine-related products, the courts and to law enforcement
15 agencies for law enforcement purposes.

16 C. The registry shall consist of the following information:

- 17 1. Name of the person;
- 18 2. Date of birth of the person;
- 19 3. The offense or offenses which made the person eligible for
20 inclusion on the registry;
- 21 4. The conviction date;
- 22 5. The county where the offense or offenses occurred; and
- 23 6. Such other identifying data as the Bureau determines is
24 necessary to properly identify the person.

1 D. Beginning November 1, 2010, all district court clerks shall
2 forward a copy of the judgment and sentence and date of birth of all
3 persons who are convicted of a violation of the offenses described
4 in subsection A of this section to the Bureau. Such information
5 shall be forwarded to the Bureau within forty-five (45) days of the
6 date of judgment and sentence.

7 E. The Bureau shall remove from the registry the name and other
8 identifying information of a person who has been convicted of a
9 violation of any of the offenses described in subsection A of this
10 section ten (10) years after the date of the most recent judgment
11 and sentence. Any person having received a deferred sentence that
12 expires prior to the ten-year time limitation may provide to the
13 Bureau a certified copy of the dismissal of the case by certified
14 mail to the Bureau. The Bureau may remove the person from the
15 registry upon expiration of the deferred sentence.

16 F. It shall be a violation for any person to assist another
17 person who is on the registry in the purchase of any pseudoephedrine
18 products. Any person convicted of violating the provisions of this
19 subsection shall, for a first offense, be guilty of a misdemeanor,
20 punishable by incarceration in the county jail for not more than one
21 (1) year, or by a fine of not more than One Thousand Dollars
22 (\$1,000.00), or by both such fine and imprisonment. Any second or
23 subsequent conviction for a violation of this subsection shall be a
24 felony, punishable by incarceration in the custody of the Department

1 of Corrections for two (2) years, or by a fine of not less than Two
2 Thousand Five Hundred Dollars (\$2,500.00) or by both such fine and
3 imprisonment.

4 SECTION 3. This act shall become effective November 1, 2010.
