7 AS INTRODUCED

8 A Resolution commending the University of Oklahoma  
9 Women's Basketball Team; and directing distribution.  
10

11 WHEREAS, OU Women's basketball was the first team in the state's  
12 history to appear in consecutive Final Fours in present tournament  
13 format; and

14 WHEREAS, OU Women's basketball became one of just eight programs  
15 in women's college basketball history to advance to consecutive  
16 Final Four appearances; and

17 WHEREAS, OU Women's basketball played the nation's toughest  
18 schedule, meeting 22 ranked teams through the course of the season,  
19 including all four No. 1 seeds of the NCAA Championship; and

20 WHEREAS, OU Women's basketball earned its seventh All-America  
21 selection as junior Danielle Robinson was voted to both the coaches'  
22 and media's top teams; and

23 WHEREAS, OU Women's basketball had three representatives on the  
24 All-Big 12 Conference team as Danielle Robinson and Amanda Thompson

1 were voted to the first team and Nyeshia Stevenson to the second  
2 team; and

3 WHEREAS, OU Women's basketball had three representatives on the  
4 Academic All-Big 12 Conference team with Jasmine Hartman, Danielle  
5 Robinson and Amanda Thompson; and

6 WHEREAS, OU Women's basketball carried a cumulative team GPA of  
7 3.15; and

8 WHEREAS, OU Women's basketball achieved an average home  
9 attendance that ranked among the top eight nationally for the fifth  
10 consecutive year; and

11 WHEREAS, OU Women's basketball finished the season with 27 wins,  
12 the sixth most in the program's history; and

13 WHEREAS, OU Women's basketball has, under the coaching of Sherri  
14 Coale and through its outstanding performance, become a source of  
15 pride for the State of Oklahoma; and

16 WHEREAS, the Oklahoma House of Representatives of the 52nd  
17 Legislature takes pride in recognizing the OU Women's Basketball  
18 Team.

19 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES  
20 OF THE 2ND SESSION OF THE 52ND OKLAHOMA LEGISLATURE:

21 THAT sincere commendation and congratulations is hereby extended  
22 to the University of Oklahoma Women's Basketball Team for their many  
23 outstanding accomplishments during the 2009-2010 basketball season.
