6 AS INTRODUCED

7 A Joint Resolution directing the Secretary of State
8 to refer to the people for their approval or
9 rejection a proposed amendment to Section 21 of
10 Article X of the Constitution of the State of
11 Oklahoma; modifying membership of the State Board of
12 Equalization; providing for chair of Corporation
13 Commission as member; providing ballot title; and
14 directing filing.

15 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE
16 2ND SESSION OF THE 52ND OKLAHOMA LEGISLATURE:

17 SECTION 1. The Secretary of State shall refer to the people for
18 their approval or rejection, as and in the manner provided by law,
19 the following proposed amendment to Section 21 of Article X of the
20 Constitution of the State of Oklahoma to read as follows:

21 Section 21. A. There shall be a State Board of Equalization
22 consisting of the Governor, State Auditor, State Treasurer,
23 Lieutenant Governor, Attorney General, State Inspector and Examiner
24 ~~and, the~~ President of the Board of Agriculture and the chair of the
Corporation Commission. The duty of said Board shall be to adjust
and equalize the valuation of real and personal property of the

1 several counties in the state, and it shall perform such other
2 duties as may be prescribed by law, and they shall assess all
3 railroad and public service corporation property.

4 B. Should the Offices of State Examiner and Inspector and State
5 Auditor be consolidated in the Office of State Auditor and
6 Inspector, the State Auditor shall be replaced as a member of the
7 State Board of Equalization by the State Auditor and Inspector and
8 the Superintendent of Public Instruction shall be added as a member
9 thereof. Should the offices not be so consolidated, the membership
10 shall remain the same as provided in subsection A of this section
11 and the Superintendent of Public Instruction shall not be added to
12 the membership.

13 SECTION 2. The Ballot Title for the proposed Constitutional
14 amendment as set forth in SECTION 1 of this resolution shall be in
15 the following form:

18 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

19 This measure amends the Oklahoma Constitution. It amends
20 Section 21 of Article 10. This section creates the State Board
21 of Equalization. This measure would cause the chair of the
22 Corporation Commission to be added as a member of the State
23 Board of Equalization.
