6 AS INTRODUCED

7 An Act relating to professions and occupations;
8 amending 59 O.S. 2001, Section 887.4, which relates
9 to the Physical Therapy Committee; modifying certain
requirement for membership; and providing an
effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 59 O.S. 2001, Section 887.4, is
14 amended to read as follows:

15 Section 887.4 A. There is hereby established a Physical
16 Therapy Committee to assist the State Board of Medical Licensure and
17 Supervision in conducting examinations for applicants and to advise
18 the Board on all matters pertaining to the licensure, education, and
19 continuing education of physical therapists and physical therapist
20 assistants and the practice of physical therapy.

21 B. 1. The Physical Therapy Committee shall consist of five (5)
22 members who shall be appointed by the State Board of Medical
23 Licensure and Supervision as follows:

24 a. three members shall be licensed physical therapists,

- 1 b. one member shall be a licensed physical therapist
- 2 assistant, and
- 3 c. one member shall be a lay person.

4 2. Except for the lay appointee, each appointee shall be
5 selected from a list of three persons submitted for each vacancy by
6 the Oklahoma Chapter of the American Physical Therapy Association.

- 7 a. Members serving on the Committee on the effective date
8 of this act may continue serving until expiration of
9 their terms of office and may be reappointed if
10 eligible pursuant to the provisions of this act.

11 Members of the original Physical Therapy Committee
12 shall have been appointed for staggered terms of one
13 (1), two (2), and three (3) years, respectively.

14 Terms of office of each appointed member shall expire
15 July 1 of that year in which they expire regardless of
16 the calendar date when such appointments were made.

17 Subsequent appointments shall be made for a term of
18 three (3) years or until their successors are
19 appointed and qualified.

- 20 b. The lay member and physical therapist assistant member
21 initially appointed to fill the two new positions
22 created pursuant to this act shall be appointed for
23 staggered terms of office which will expire July 1,
24 1998, and July 1, 1999. Thereafter, members appointed

1 to these positions shall serve for terms of three (3)
2 years or until their successors are appointed and
3 qualified.

4 c. Vacancies shall be filled by the Board in the same
5 manner as the original appointment.

6 3. Each member of the Committee shall be a resident of this
7 state. The physical therapist and physical therapist assistant
8 members shall be licensed pursuant to the Physical Therapy Practice
9 Act for at least ~~three (3)~~ four (4) years prior to appointment to
10 the Committee. The lay member shall not be a physical therapist or
11 a licensed health care professional or be related by adoption,
12 blood, or marriage within the third degree of consanguinity to a
13 physical therapist or a licensed health care professional.

14 4. Members of the Committee shall be reimbursed for all actual
15 and necessary expenses incurred in the performance of duties
16 required by the Physical Therapy Practice Act in accordance with the
17 provisions of the State Travel Reimbursement Act.

18 C. The Committee shall have the power and duty to:

19 1. Assist in selecting and conducting examinations for
20 licensure, and in determining which applicants successfully passed
21 such examination;

22 2. Advise the Board on all matters pertaining to the licensure,
23 education, and continuing education requirements for, and practice
24 of physical therapy in this state;

1 3. Maintain a current list of approved schools of physical
2 therapy and physical therapist assistants; and

3 4. Assist and advise in all hearings involving physical
4 therapists or physical therapist assistants who are deemed to be in
5 violation of the Physical Therapy Practice Act.

6 SECTION 2. This act shall become effective November 1, 2009.
