9 AS INTRODUCED

10 An Act relating to the Department of Mental Health
11 and Substance Abuse Services; making an
12 appropriation; stating purpose; requiring budgeting
13 in certain categories and amounts; requiring certain
14 performance measures; providing for duties and
15 compensation of employees; limiting salary of the
16 Commissioner; providing budgetary limitations; and
17 providing an effective date.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. There is hereby appropriated to the Department of
20 Mental Health and Substance Abuse Services from any monies not
21 otherwise appropriated from the General Revenue Fund of the State
22 Treasury for the fiscal year ending June 30, 2010, the sum of
23 _____ Dollars (\$0.00) or so much thereof as may be necessary
24 to perform the duties imposed upon the Department of Mental Health
and Substance Abuse Services by law.

1 SECTION 2. For the fiscal year ending June 30, 2010, the
2 Department of Mental Health and Substance Abuse Services shall
3 budget all funds in the following categories and amounts:

12 The agency shall develop outcome-based performance measures for
13 each budget category.

14 SECTION 3. The duties and compensation of employees, not
15 otherwise prescribed by law, necessary to perform the duties imposed
16 upon the Department of Mental Health and Substance Abuse Services by
17 law shall be set by the Commissioner of the Department of Mental
18 Health and Substance Abuse Services. The salary of the Commissioner
19 of the Department of Mental Health and Substance Abuse Services
20 shall not exceed _____ Dollars (\$0.00) per annum, payable monthly
21 for the fiscal year ending June 30, 2010. The Department of Mental
22 Health and Substance Abuse Services for the fiscal year ending June
23 30, 2010, shall be subject to the following budgetary limitations on
24 full-time-equivalent employees and expenditures excluding

1 expenditures for capital and special projects, except as may be
2 authorized pursuant to the provisions of Section 3603 of Title 74 of
3 the Oklahoma Statutes:
