6 AS INTRODUCED

7 An Act relating to the State Capitol; amending 73
8 O.S. 2001, Sections 15.1, as last amended by Section
9 1, Chapter 317, O.S.L. 2009 and 98.6 (73 O.S. Supp.
10 2009, Section 15.1), which relate to management and
11 control of space in State Capitol Building; providing
12 that certain provisions not prohibit certain use of
13 space in State Capitol; modifying space under
14 management and control of Legislature; and providing
15 an effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 73 O.S. 2001, Section 15.1, as
18 last amended by Section 1, Chapter 317, O.S.L. 2009 (73 O.S. Supp.
19 2009, Section 15.1), is amended to read as follows:

20 Section 15.1 A. The Legislature shall have management and
21 control of the following space in the State Capitol Building:

- 22 1. The space on the third, fourth, fifth and sixth floors;
- 23 2. The space in the basement that is occupied by the
24 Legislature on June 1, 1995;

1 3. Approximately six thousand nine hundred thirty-nine (6,939)
2 square feet of space in the west wing of the first floor that is
3 occupied by the Department of Libraries on June 1, 1995;

4 4. Approximately six thousand six hundred ninety-one (6,691)
5 square feet of space in the west wing of the basement that is
6 occupied by the Department of Libraries and the Department of
7 Central Services on June 1, 1995;

8 5. Approximately three thousand seven hundred seventy (3,770)
9 square feet of space in the west wing of the basement that is
10 occupied by the Department of Central Services on June 1, 1995;

11 6. Approximately two thousand one hundred (2,100) square feet
12 of space in the center of the basement that is occupied by the
13 Department of Central Services and the Office of State Finance on
14 June 1, 1995;

15 7. Approximately six hundred (600) square feet of space in the
16 center of the basement that is occupied by the Department of Central
17 Services on June 1, 1995;

18 8. Approximately two thousand three hundred one (2,301) square
19 feet of space in the center of the basement that is occupied by the
20 Department of Central Services on June 1, 1995;

21 9. Approximately twelve thousand five hundred sixty (12,560)
22 square feet of space in the west wing of the first floor that is
23 occupied by the Office of the Attorney General on June 1, 2001;
24 provided, upon the Office of the Attorney General vacating such

1 space, any renovations thereto shall be made in such a manner as to
2 ensure preservation and maintenance of the cultural and historic
3 integrity of the Capitol; and

4 10. Upon completion of the project authorized in Section 332 of
5 this title, all space in the west wing of the second floor that is
6 occupied by the Supreme Court, all space in the north wing of the
7 second floor that is occupied by the Court of Criminal Appeals and
8 any other space in the State Capitol Building that is occupied by
9 the appellate courts prior to relocation to the Wiley Post
10 Historical Building; provided, the Supreme Court and the Court of
11 Criminal Appeals shall continue to have access to the courtrooms and
12 designated robing rooms located in the west and north wings of the
13 second floor upon such occasions as the Chief Justice of the Supreme
14 Court or the Presiding Judge of the Court of Criminal Appeals deems
15 necessary and appropriate.

16 B. The authority of the Legislature to allot space may be
17 delegated to the President Pro Tempore of the Senate and the Speaker
18 of the House of Representatives. Each House of the State
19 Legislature shall have the exclusive charge of the purchase, use,
20 allotment, and disposition of its respective chambers, committee
21 rooms, fixtures, furniture, supplies, and apparatus, and shall be
22 responsible for the use and preservation of same. The provisions of
23 this section shall not prohibit the Legislature from allowing
24 agencies of the executive or judicial departments to use space

1 within the State Capitol Building that is under its management and
2 control.

3 SECTION 2. AMENDATORY 73 O.S. 2001, Section 98.6, is
4 amended to read as follows:

5 Section 98.6 Notwithstanding any other provision of law to the
6 contrary, the ~~Oklahoma Capitol Complex and Centennial Commemoration~~
7 ~~Commission~~ Legislature shall have the management and control of the
8 following space in the State Capitol Building:

9 The four offices and all space in the approximately 1,000 square
10 feet of space on the first floor in the area designated as room 105,
11 using January 1, 2001, as the reference point.

12 SECTION 3. This act shall become effective November 1, 2010.
