7 An Act relating to state officers; amending 74 O.S.
8 2001, Section 250.4, which relates to state officers
9 salaries; providing salaries; eliminating procedure
10 linking salaries to judicial salaries; and providing
11 an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 74 O.S. 2001, Section 250.4, is
14 amended to read as follows:

15 Section 250.4 Pursuant to provisions of the Constitution of the
16 State of Oklahoma from and after the beginning date of a term of
17 office which commences in, or after, January, ~~1999~~ 2011, the
18 following officers of the State of Oklahoma shall be annually
19 compensated for their services, payable monthly, as follows:

20 1. The Governor shall receive a salary ~~equal to the salary~~
21 ~~received by the Chief Justice of the Oklahoma Supreme Court of One~~
22 Hundred Forty-seven Thousand Dollars (\$147,000.00);

23 2. The Lieutenant Governor shall receive a salary ~~equal to the~~
24 ~~salary received by an associate district judge in a county with a~~

1 ~~population greater than ten thousand (10,000) and less than thirty~~
2 ~~thousand (30,000) of One Hundred Fourteen Thousand Seven Hundred~~
3 ~~Thirteen Dollars (\$114,713.00);~~

4 3. The Attorney General shall receive a salary ~~equal to the~~
5 ~~salary received by the Presiding Judge of the Court of Civil Appeals~~
6 ~~of One Hundred Thirty-two Thousand Eight Hundred Twenty-five Dollars~~
7 ~~(\$132,825.00);~~

8 4. The State Superintendent of Public Instruction shall receive
9 a salary ~~equal to the salary received by a district judge of One~~
10 ~~Hundred Twenty-four Thousand Three Hundred Seventy-three Dollars~~
11 ~~(\$124,373.00);~~

12 5. Each member of the Corporation Commission shall receive a
13 salary ~~equal to the salary received by an associate district judge~~
14 ~~in a county with a population of over thirty thousand (30,000) of~~
15 ~~One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars~~
16 ~~(\$114,713.00);~~

17 6. The State Treasurer shall receive a salary ~~equal to the~~
18 ~~salary received by an associate district judge in a county with a~~
19 ~~population of over thirty thousand (30,000) of One Hundred Fourteen~~
20 ~~Thousand Seven Hundred Thirteen Dollars (\$114,713.00);~~

21 7. The State Auditor and Inspector shall receive a salary ~~equal~~
22 ~~to the salary received by an associate district judge in a county~~
23 ~~with a population of over thirty thousand (30,000) of One Hundred~~
24 ~~Fourteen Thousand Seven Hundred Thirteen Dollars (\$114,713.00);~~

1 8. The State Insurance Commissioner shall receive a salary
2 ~~equal to the salary received by an associate district judge in a~~
3 ~~county with a population of over thirty thousand (30,000) of One~~
4 Hundred Fourteen Thousand Seven Hundred Thirteen Dollars
5 (\$114,713.00); and

6 9. The Commissioner of Labor shall receive a salary ~~equal to~~
7 ~~the salary received by a special judge of One Hundred Five Thousand~~
8 Fifty-three Dollars (\$105,053.00).

9 SECTION 2. This act shall become effective November 1, 2010.
