10 An Act relating to general appropriations for the
11 expenses of various agencies of the executive,
12 legislative and judicial departments of the state;
13 making appropriations to the Oklahoma Arts Council,
14 the State Board of Education, the Oklahoma
15 Educational Television Authority, the Oklahoma State
16 Regents for Higher Education, the Oklahoma Department
17 of Libraries, the Commissioners of the Land Office,
18 the Physician Manpower Training Commission, the
19 Oklahoma Board of Private Vocational Schools, the
20 Board of Trustees of the Oklahoma School of Science
21 and Mathematics, the Oklahoma Center for the
22 Advancement of Science and Technology, the Oklahoma
23 Commission for Teacher Preparation, the State Board

appropriations; stating purposes and restrictions;
authorizing and requiring certain expenditures;
requiring transfer of certain funds; and providing an
effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SUBCOMMITTEE ON EDUCATION

2 SECTION 1. There is hereby appropriated to the Oklahoma Arts
3 Council from any monies not otherwise appropriated from the General
4 Revenue Fund of the State Treasury for the fiscal year ending June
5 30, 2010, the sum of _____ Dollars (\$0.00) or so much thereof
6 as may be necessary to perform the duties imposed upon the Oklahoma
7 Arts Council by law.

8 SECTION 2. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
12 much thereof as may be necessary for the financial support of public
13 schools.

14 SECTION 3. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 Education Reform Revolving Fund created in Section 41.29b of Title
17 62 of the Oklahoma Statutes, the sum of _____ Dollars (\$0.00)
18 or so much thereof as may be necessary for the financial support of
19 public schools.

20 SECTION 4. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Mineral Leasing Fund of the State Treasury for the fiscal year
23 ending June 30, 2008, the sum of _____ Dollars (\$0.00) or so
24

1 much thereof as may be necessary for the financial support of public
2 schools.

3 SECTION 5. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Mineral Leasing Fund of the State Treasury for the fiscal year
6 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary for the financial support of public
8 schools.

9 SECTION 6. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
13 much thereof as may be necessary for the support of public school
14 activities.

15 SECTION 7. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Special Cash Fund of the State Treasury, the sum of _____
18 Dollars (\$0.00) or so much thereof as may be necessary for the
19 purchase of textbooks.

20 SECTION 8. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 General Revenue Fund of the State Treasury for the fiscal year
23 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
24

1 much thereof as may be necessary to perform the duties imposed upon
2 the Office of Accountability by law.

3 SECTION 9. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary for Administrative and Support
8 Functions of the State Department of Education.

9 SECTION 10. There is hereby appropriated to the Oklahoma
10 Educational Television Authority from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2010, the sum of _____
13 Dollars (\$0.00) or so much thereof as may be necessary to perform
14 the duties imposed upon the Oklahoma Educational Television
15 Authority by law.

16 SECTION 11. There is hereby appropriated to the Oklahoma State
17 Regents for Higher Education from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2010, the sum of _____ Dollars
20 (\$0.00) or so much thereof as may be necessary for allocation by the
21 Oklahoma State Regents for Higher Education pursuant to the
22 provisions of Article XIII-A of the Oklahoma Constitution for the
23 education and general operating budgets of the institutions and for
24

1 other programs, construction, renovations or repairs administered by
2 the Oklahoma State Regents for Higher Education.

3 SECTION 12. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2010, the sum of _____
7 Dollars (\$0.00) or so much thereof as may be necessary for the
8 general operating budget of the Administrative Offices of the
9 Oklahoma State Regents for Higher Education.

10 SECTION 13. There is hereby appropriated to the Oklahoma State
11 Regents for Higher Education from any monies not otherwise
12 appropriated from the Special Cash Fund of the State Treasury, the
13 sum of _____ Dollars (\$0.00) or so much thereof as may be
14 necessary for allocation by the Oklahoma State Regents for Higher
15 Education pursuant to the provisions of Article XIII-A of the
16 Oklahoma Constitution for the education and general operating
17 budgets of the institutions and for other programs, construction,
18 renovations or repairs administered by the Oklahoma State Regents
19 for Higher Education.

20 SECTION 14. There is hereby appropriated to the Oklahoma
21 Department of Libraries from any monies not otherwise appropriated
22 from the General Revenue Fund of the State Treasury for the fiscal
23 year ending June 30, 2010, the sum of _____ Dollars (\$0.00)

1 or so much thereof as may be necessary to perform the duties imposed
2 upon the Oklahoma Department of Libraries by law.

3 SECTION 15. There is hereby appropriated to the Commissioners
4 of the Land Office from any monies not otherwise appropriated from
5 the Commissioners of the Land Office Fund of the State Treasury for
6 the fiscal year ending June 30, 2010, the sum of _____
7 Dollars (\$0.00) or so much thereof as may be necessary to perform
8 the duties imposed upon the Commissioners of the Land Office by law.

9 SECTION 16. There is hereby appropriated to the Physician
10 Manpower Training Commission from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2010, the sum of _____
13 Dollars (\$0.00) or so much thereof as may be necessary to perform
14 the duties imposed upon the Physician Manpower Training Commission
15 by law.

16 SECTION 17. There is hereby appropriated to the Physician
17 Manpower Training Commission from any monies not otherwise
18 appropriated from the Special Cash Fund of the State Treasury, the
19 sum of _____ Dollars (\$0.00) or so much thereof as may be
20 necessary to perform the duties imposed upon the Physician Manpower

15 Treasury for the fiscal year ending June 30, 2010, the sum of
16 _____ Dollars (\$0.00) or so much thereof as may be necessary
17 to perform the duties imposed upon the Oklahoma Center for the
18 Advancement of Science and Technology by law.

19 SECTION 21. There is hereby appropriated to the Oklahoma
20 Commission for Teacher Preparation from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2010, the sum of _____
23 Dollars (\$0.00) or so much thereof as may be necessary to perform

3 SECTION 22. There is hereby appropriated to the Oklahoma

7 necessary to perform the duties imposed upon the Oklahoma Commission

9 SECTION 23. There is hereby appropriated to the State Board of
10 Career and Technology Education from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2010, the sum of _____
13 Dollars (\$0.00) or so much thereof as may be necessary to perform
14 the duties imposed upon the State Board of Career and Technology
15 Education by law.

17 SECTION 24. There is hereby appropriated to the Office of the
18 State Auditor and Inspector from any monies not otherwise
19 appropriated from the General Revenue Fund of the State Treasury for
20 the fiscal year ending June 30, 2010, the sum of _____
21 Dollars (\$0.00) or so much thereof as may be necessary to perform
22 the duties imposed upon the Office of the State Auditor and
23 Inspector by law.

1 SECTION 25. There is hereby appropriated to the Office of the
2 State Auditor and Inspector from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2010, the sum of _____
5 Dollars (\$0.00) or so much thereof as may be necessary to perform
6 the duties imposed upon the Commission on County Government
7 Personnel Education and Training. The appropriation made in this
8 section shall be expended exclusively for the purpose so stated and
9 shall not be transferable.

10 SECTION 26. There is hereby appropriated to the Office of the
11 State Auditor and Inspector from any monies not otherwise
12 appropriated from the General Revenue Fund of the State Treasury for
13 the fiscal year ending June 30, 2010, the sum of _____
14 Dollars (\$0.00) or so much thereof as may be necessary to provide
15 uniform computer systems development, including computer software
16 for county government, in accordance with the State Auditor and
17 Inspector's duties to prescribe accounting procedures and to provide
18 technical assistance to county government. The appropriation made
19 in this section shall be expended exclusively for the purpose so
20 stated and shall not be transferable.

21 SECTION 27. There is hereby appropriated to the Office of the
22 State Bond Advisor from any monies not otherwise appropriated from
23 the General Revenue Fund of the State Treasury for the fiscal year
24 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so

1 much thereof as may be necessary to perform the duties imposed upon
2 the Office of the State Bond Advisor by law.

3 SECTION 28. There is hereby appropriated to the Rural Economic
4 Action Plan Fund of the State Treasury from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2010, the sum of _____
7 Dollars (\$0.00) or so much thereof as may be necessary to implement
8 the provisions of Section 2006 through 2013 of Title 62 of the
9 Oklahoma Statutes.

10 SECTION 29. There is hereby appropriated to the Department of
11 Central Services from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
14 much thereof as may be necessary to perform the duties imposed upon
15 the Department of Central Services by law.

16 SECTION 30. There is hereby appropriated to the Department of
17 Central Services from any monies not otherwise appropriated from the
18 General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2010, the sum of _____ Dollars (\$0.00) to be
20 transferred to the Building and Facility Revolving Fund created in
21 Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of
22 maintaining state buildings operated by the Department of Central
23 Services.

1 SECTION 31. There is hereby appropriated to the Department of
2 Central Services from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
5 much thereof as may be necessary to perform maintenance on the
6 Veterans Memorial within the capitol complex.

7 SECTION 32. There is hereby appropriated to the Department of
8 Central Services from any monies not otherwise appropriated from the
9 Public Building Fund of the State Treasury for the fiscal year
10 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
11 much thereof as may be necessary for asbestos abatement programs and
12 for the expenses of filing claims for reimbursement from the
13 Manville Property Damage Settlement Trust. The monies designated in
14 this section shall be expended exclusively for the purposes so
15 stated and shall not be transferable.

16 SECTION 33. There is hereby appropriated to the Department of
17 Central Services from any monies not otherwise appropriated from the
18 General Revenue Fund of the State Treasury for the fiscal year
19 ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so
20 much thereof as may be necessary to maintain the Hissom Memorial
21 Center.

7 30, 2010, the sum of _____ Dollars (\$0.00) or so much thereof
8 as may be necessary to pay monthly salaries, per diem, and expenses
9 of the members of the Senate and the salaries of its employees, and
10 such contingent expenses as may be ordered paid therefrom, including
11 the preparation and printing of the journals and calendars of the
12 Senate, and including the preparation and printing of the permanent
13 journals thereof, in accordance with the following amount herein set
14 forth:
