6 AS INTRODUCED

7 An Act relating to the district courts; authorizing
8 an expenditure by the Supreme Court for the district
9 courts; stating purpose; requiring budgeting in
10 certain categories and amounts; limiting salaries of
11 certain employees; providing budgetary limitations;
and providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. The Supreme Court is hereby authorized to expend
14 during the fiscal year ending June 30, 2010, from the State Judicial
15 Revolving Fund of the State Treasury, the sum of _____
16 Dollars (\$0.00) or so much thereof as may be necessary for the
17 financial support of the district courts.

18 SECTION 2. For the fiscal year ending June 30, 2010, the
19 Supreme Court shall budget all funds appropriated or otherwise made
20 available for the operation of the district courts in the following
21 categories and amounts:

1 SECTION 3. For the fiscal year ending June 30, 2010, the annual
 2 compensation of the following employees of the district courts
 3 payable monthly from appropriated funds shall not exceed the
 4 following schedule, exclusive of overtime and longevity payments,
 5 except as may be authorized pursuant to the provisions of Section
 6 3603 of Title 74 of the Oklahoma Statutes:

10 SECTION 4. The district courts, for the fiscal year ending June
 11 30, 2010, shall be subject to the following budgetary limitations on
 12 full-time-equivalent employees excluding active retired judges, and
 13 except as may be authorized pursuant to the provisions of Section
 14 3603 of Title 74 of the Oklahoma Statutes.
