SENATE BILL 361

AS INTRODUCED

An Act relating to the Alcoholic Beverage Laws Enforcement Commission; making an appropriation; stating purpose; requiring budgeting in certain categories and amounts; requiring certain performance measures; providing for duties and compensation of employees; limiting salary of the Director; providing budgetary limitations; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Alcoholic Beverage Laws Enforcement Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2010, the sum of _____ Dollars (\$0.00) or so much thereof as may be necessary to perform the duties imposed upon the Alcoholic Beverage Laws Enforcement Commission by law.

SECTION 2. For the fiscal year ending June 30, 2010, the Alcoholic Beverage Laws Enforcement Commission shall budget all funds in the following categories and amounts:

7 SECTION 3. The duties and compensation of employees, not
8 otherwise prescribed by law, necessary to perform the duties imposed
9 upon the Alcoholic Beverage Laws Enforcement Commission by law shall
10 be set by the Director. The salary of the Director shall not exceed
11 _____ Dollars (\$0.00) per annum, payable monthly for the
12 fiscal year ending June 30, 2010. The Alcoholic Beverage Laws
13 Enforcement Commission for the fiscal year ending June 30, 2010,
14 shall be subject to the following budgetary limitations on full-
15 time-equivalent employees and expenditures excluding expenditures
16 for capital and special projects, except as may be authorized
17 pursuant to the provisions of Section 3603 of Title 74 of the
18 Oklahoma Statutes:
