6 AS INTRODUCED

7 An Act relating to public health and safety; amending  
8 Section 8, Chapter 393, O.S.L. 2008 (63 O.S. Supp.  
9 2008, Section 1-2512.1), which relates to the Oklahoma  
10 Emergency Response Systems Stabilization and  
11 Improvement Revolving Fund; modifying authorized  
expenditures of the Oklahoma Emergency Response  
Systems Stabilization and Improvement Revolving Fund;  
providing an effective date; and declaring an  
emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY Section 8, Chapter 393, O.S.L. 2008  
16 (63 O.S. Supp. 2008, Section 1-2512.1), is amended to read as  
17 follows:

18 Section 1-2512.1. A. There is hereby created in the State  
19 Treasury a revolving fund for the State Department of Health to be  
20 designated the "Oklahoma Emergency Response Systems Stabilization and  
21 Improvement Revolving Fund". The fund shall be a continuing fund,  
22 not subject to fiscal year limitations, and shall consist of monies  
23 received by the State Department of Health in accordance with state  
24 law. All monies accruing to the credit of the fund are hereby

1 appropriated and may be budgeted and expended by the Department for  
2 the purpose of ~~funding assessment activities, stabilization and/or~~  
3 ~~reorganization of at risk emergency medical services, development of~~  
4 ~~regional emergency medical services, training for emergency medical~~  
5 ~~directors,~~ access to training front line emergency medical services  
6 personnel, capital and equipment needs. Expenditures from the fund  
7 shall be made upon warrants issued by the State Treasurer against  
8 claims filed as prescribed by law with the Director of State Finance  
9 for approval and payment.

10 B. The State Board of Health shall promulgate rules establishing  
11 a formula and procedure for the distribution of funds from the  
12 Oklahoma Emergency Response Systems Stabilization and Improvement  
13 Revolving Fund.

14 SECTION 2. This act shall become effective July 1, 2009.

15 SECTION 3. It being immediately necessary for the preservation  
16 of the public peace, health and safety, an emergency is hereby  
17 declared to exist, by reason whereof this act shall take effect and  
18 be in full force from and after its passage and approval.
