6 AS INTRODUCED

7 An Act relating to the Office of the State Fire  
8 Marshal; amending 74 O.S. 2001, Sections 324.20b, as  
9 last amended by Section 4, Chapter 269, O.S.L. 2005  
10 and Section 324.21 (74 O.S. Supp 2008, Section  
11 324.20b), which relate to the State Fire Marshal  
12 Revolving Fund; removing monetary limit; modifying  
13 deposit placement; providing an effective date; and  
14 declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 74 O.S. 2001, Section 324.20b, as  
17 last amended by Section 4, Chapter 269, O.S.L. 2005 (74 O.S. Supp.  
18 2008, Section 324.20b), is amended to read as follows:

19 Section 324.20b There is hereby created in the State Treasury a  
20 revolving fund for the State Fire Marshal to be designated the  
21 "State Fire Marshal Revolving Fund". The fund shall be a continuing  
22 fund, not subject to fiscal year limitations, and shall consist of  
23 monies received from the sale of surplus property, fees and receipts  
24 collected pursuant to the Oklahoma Open Records Act, fines,  
forfeitures, fees, charges, receipts, donations, gifts, bequests,

1 contributions, devises, interagency reimbursements, federal funds  
2 unless otherwise provided by federal law or regulation, or any other  
3 source. ~~The fund shall consist of no more than Five Hundred Fifty~~  
4 ~~Thousand Dollars (\$550,000.00).~~ All monies accruing to the credit  
5 of the fund are hereby appropriated and may be budgeted and expended  
6 by the State Fire Marshal for authorized purposes. Expenditures  
7 from the fund shall be made upon warrants issued by the State  
8 Treasurer against claims filed as prescribed by law with the  
9 Director of State Finance for approval and payment.

10 SECTION 2. AMENDATORY 74 O.S. 2001, Section 324.21, is  
11 amended to read as follows:

12 Section 324.21 The Office of the State Fire Marshal shall be  
13 authorized to prepare under the Seal of the Office and deliver upon  
14 request, a certified copy of fire investigation reports, as  
15 authorized in Section 314 of ~~Title 74 of the Oklahoma Statutes~~ this  
16 title, charging a fee of Two Dollars (\$2.00) per page for each  
17 document so authenticated. Fees collected by the Office of the State  
18 Fire Marshal shall be deposited in the ~~State Treasury for credit to~~  
19 ~~the General Revenue Fund of the state~~ State Fire Marshal Revolving  
20 Fund.

21 SECTION 3. This act shall become effective July 1, 2009.

22 SECTION 4. It being immediately necessary for the preservation  
23 of the public peace, health and safety, an emergency is hereby  
24

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
