14 AMENDMENT NO. 1. Strike the title, enacting clause and entire bill
15 and insert

16 "An Act relating to dedication of memorial highways;
17 designating the Major Scott Hagerty USAR Memorial
18 Highway; designating the Dr. Walter S. Mason, Jr.
19 Memorial Highway; designating the Chief Warrant
20 Officer Gordon Spangler Memorial Highway;
21 designating the Cpl. Joshua Jerold Ware Memorial
22 Highway; requiring certain permanent markers;
23 providing for codification; and providing an
24 effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.93 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The section of State Highway 177 from the intersection of State
5 Highway 33 in Perkins north to the Stillwater municipal limits shall
6 be designated as "Major Scott Hagerty USAR Memorial Highway". The
7 Department of Transportation shall cause suitable permanent markers
8 to be placed on the highway bearing that name.

9 SECTION 2. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.94 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The portion of Interstate 40 between mile makers 65 and 66 in
13 Custer County shall be designated as the "Dr. Walter S. Mason, Jr.
14 Memorial Highway". The Department of Transportation shall cause
15 suitable permanent markers to be placed upon the highway bearing
16 that name.

17 SECTION 3. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 1698.95 of Title 69, unless
19 there is created a duplication in numbering, reads as follows:

20 The portion of State Highway 19 in Grady County extending from
21 the intersection of State Highway 19 and State Highway 81 east to
22 the Little Washita River Bridge shall be designated as the "Chief
23 Warrant Officer Gordon Spangler Memorial Highway". The Department

1 of Transportation shall cause suitable permanent markers to be
2 placed on the highway bearing that name.

3 SECTION 4. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.96 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The portion of State Highway 64 in Sequoyah County extending
7 from the Roland city limits east to the Oklahoma-Arkansas state line
8 shall be designated as the "Cpl. Joshua Jerold Ware Memorial
9 Highway". The Department of Transportation shall cause suitable
10 permanent markers to be placed on the highway bearing that name.

11 SECTION 5. This act shall become effective November 1, 2011."

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 6. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.93 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The section of State Highway 177 from the intersection of State
16 Highway 33 in Perkins north to the Stillwater municipal limits shall
17 be designated as "Major Scott Hagerty USAR Memorial Highway". The
18 Department of Transportation shall cause suitable permanent markers
19 to be placed on the highway bearing that name.

20 SECTION 7. This act shall become effective November 1, 2011.
