20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. AMENDATORY 47 O.S. 2011, Section 2-105.2, is  
22 amended to read as follows:

23 Section 2-105.2 The Department of Public Safety is authorized  
24 to conduct Highway Patrol Academies as may be required and within

1 the funds available to the Department. The Department shall provide  
2 the Governor, Speaker of the House of Representatives and President  
3 Pro Tempore of the Senate quarterly reports stating the staffing  
4 levels within the Oklahoma Highway Patrol and whether the personal  
5 safety of Highway Patrol Troopers is at an increased risk due to  
6 staffing deficiencies. Provided, however, that no such academy  
7 shall be commenced nor shall any funds be expended for an academy  
8 until:

9 1. The academy has been approved for implementation by the  
10 Contingency Review Board; or

11 2. The Legislature has authorized the academy.

12 SECTION 2. This act shall become effective November 1, 2012."

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 3. AMENDATORY 47 O.S. 2011, Section 2-105.2, is amended to read as follows:

Section 2-105.2. The Department of Public Safety is authorized to conduct Highway Patrol Academies as may be required and within the funds available to the Department. The Department shall provide the Legislature and Governor quarterly reports stating the staffing levels within the Oklahoma Highway Patrol and whether individual Troopers' personal safety is at an increased risk due to staffing deficiencies. Provided, however, that no such academy shall be commenced nor shall any funds be expended for an academy until:

1. The academy has been approved for implementation by the Contingency Review Board; or
2. The Legislature has authorized the academy.

SECTION 4. This act shall become effective November 1, 2012.
