14 AMENDMENT NO. 1. Strike the title, enacting clause and entire bill  
and insert

16 "An Act relating to the Joint Legislative Task Force  
on the Grand River Dam Authority; amending Section  
17 3, Chapter 192, O.S.L. 2007 (82 O.S. Supp. 2010,  
Section 863.3), which relates to the task force;  
18 modifying membership of the task force; requiring  
certain biennial meetings; authorizing additional  
19 meetings; requiring certain annual report to the  
task force; prohibiting travel reimbursement;  
20 terminating membership of certain task force  
members; requiring appointment of new members by  
21 certain date; and providing for noncodification.

24 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. AMENDATORY Section 3, Chapter 192, O.S.L.  
2 2007 (82 O.S. Supp. 2010, Section 863.3), is amended to read as  
3 follows:

4 Section 863.3 A. There is hereby created the Joint Legislative  
5 Task Force on the Grand River Dam Authority for the purpose of  
6 studying the functions, activities, policies, procedures and  
7 expenditures performed by the district and any related issues the  
8 task force deems appropriate. Members of the task force shall be  
9 appointed in January of each year following a state general election  
10 by the President Pro Tempore of the Senate and the Speaker of the  
11 House of Representatives. Membership shall be made up of ~~all Senate~~  
12 ~~and House members whose legislative districts include a portion of~~  
13 ~~the Grand River Dam Authority district~~ five members of the Senate  
14 and five members of the House of Representatives whose legislative  
15 districts include a portion of the Grand River Dam Authority  
16 district to be appointed by the President Pro Tempore of the Senate  
17 and the Speaker of the House of Representatives, respectively;  
18 provided, one member shall be the House principal author of Senate  
19 Bill No. 60 of the 1st Session of the 53rd Oklahoma Legislature and  
20 one member shall be the Senate principal author of Senate Bill No.  
21 60 of the 1st Session of the 53rd Oklahoma Legislature as long as  
22 these individuals are members of the Legislature. The President Pro  
23 Tempore and Speaker shall each designate one of their members to be  
24 cochairs of the task force. The task force shall be required to

1 meet at least once biennially during the first session of each new  
2 legislature. Additional meetings may be called as the cochairs  
3 determine necessary. Meetings of the task force shall be called by  
4 the cochairs. A majority of the appointed members shall constitute  
5 a quorum for any meeting of the task force. Staffing assistance  
6 shall be provided by the staff of the Senate and House of  
7 Representatives.

8 B. The members of the task force created herein shall continue  
9 to serve until new members are appointed pursuant to the provisions  
10 of subsection A of this section. ~~Such~~ The task force is authorized  
11 to adopt any recommendations or issue any report it deems necessary.  
12 Any recommendations or reports shall be approved by a majority of  
13 the appointed members. Copies of any recommendations or reports  
14 issued by the task force shall be distributed to the Governor, the  
15 President Pro Tempore of the Senate ~~and,~~ the Speaker of the House of  
16 Representatives, the members of the Grand River Dam Authority Board  
17 of Directors and the General Manager of the Grand River Dam  
18 Authority.

19 C. The Grand River Dam Authority shall annually provide a copy  
20 of the district's most recent annual report to the members of the  
21 task force in addition to any information requested pursuant to the  
22 provisions of this section.
