10 COMMITTEE SUBSTITUTE

11 An Act relating to the University Hospitals
12 Authority; requiring transfers of certain funds;
13 requiring certain funds be used for certain programs;
14 providing an effective date; and declaring an
15 emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. TRANSFER The University Hospitals Authority
18 shall transfer the sum of Five Hundred Thousand Dollars
19 (\$500,000.00) from the funds appropriated in Section 88 of Enrolled
20 Senate Bill No. 1975 of the 2nd Session of the 53rd Oklahoma
21 Legislature to the University Hospitals Authority Disbursing Fund
22 created by Section 3221 of Title 63 of the Oklahoma Statutes, to be
23 expended in accordance with law.

1 SECTION 2. TRANSFER The University Hospitals Authority
2 shall transfer the sum of Two Million Dollars (\$2,000,000.00) from
3 the funds appropriated in Section 88 of Enrolled Senate Bill No.
4 1975 of the 2nd Session of the 53rd Oklahoma Legislature to the
5 Oklahoma Institute for Disaster and Emergency Medicine Revolving
6 Fund established pursuant to Section 1-2523 of Title 63 of the
7 Oklahoma Statutes, to be expended in accordance with law.

8 SECTION 3. TRANSFER The University Hospitals Authority
9 shall transfer the sum of Three Hundred Seventy-five Thousand
10 Dollars (\$375,000.00) from the funds appropriated in Section 88 of
11 Enrolled Senate Bill No. 1975 of the 2nd Session of the 53rd
12 Oklahoma Legislature to the Dental Loan Repayment Revolving Fund
13 established pursuant to Section 1-2714 of Title 63 of the Oklahoma
14 Statutes, to be expended in accordance with law.

15 SECTION 4. From the funds appropriated to the University
16 Hospitals Authority in Section 88 of Enrolled Senate Bill No. 1975
17 of the 2nd Session of the 53rd Oklahoma Legislature, Three Hundred
18 Fifty-six Thousand Dollars (\$356,000.00) shall be used for providing
19 hearing services for deaf and/or hard of hearing children statewide.

20 SECTION 5. From the funds appropriated to the University
21 Hospitals Authority in Section 88 of Enrolled Senate Bill No. 1975
22 of the 2nd Session of the 53rd Oklahoma Legislature, Three Million
23 Dollars (\$3,000,000.00) shall be used for patient care at the
24 University of Oklahoma Wayman Tisdale Specialty Health Clinic.

1 SECTION 6. This act shall become effective July 1, 2012.

2 SECTION 7. It being immediately necessary for the preservation
3 of the public peace, health and safety, an emergency is hereby
4 declared to exist, by reason whereof this act shall take effect and
5 be in full force from and after its passage and approval.
