BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE
2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for
their approval or rejection, as and in the manner provided by law,
the repeal of Sections 3 and 4 of Article XXV of the Constitution of
the State of Oklahoma which relate to the Oklahoma Public Welfare
Commission and the Director of Public Welfare.

SECTION 2. The Secretary of State shall refer to the people for
their approval or rejection, as and in the manner provided by law,

1 the following proposed amendment to the Constitution of the State of
2 Oklahoma by adding a new Section 6 to Article XXV thereof, to read
3 as follows:

4 Section 6. The Legislature shall have the authority and duty to
5 determine the composition and duties of the Human Services
6 Commission.

7 SECTION 3. The Ballot Title for the proposed Constitutional
8 amendment as set forth in SECTION 2 of this resolution shall be in
9 the following form:

11 Legislative Referendum No. _____ State Question No. _____

12 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

13 This measure amends the State Constitution. It provides for the
14 repeal of Sections 3 and 4 of Article 25 which relate to the
15 Oklahoma Public Welfare Commission and the Director of Public
16 Welfare. This measure grants the Legislature the authority to
17 oversee the Human Services Commission.

21 SECTION 4. The Chief Clerk of the House of Representatives,
22 immediately after the passage of this resolution, shall prepare and

2 Attorney General.
