9 COMMITTEE SUBSTITUTE

10 An Act relating to technology center school
11 districts; amending 70 O.S. 2011, Section 1-118.1,
12 which relates to building fund of technology center
13 school districts; allowing additional uses of certain
14 funds; providing an effective date; and declaring an
15 emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 70 O.S. 2011, Section 1-118.1, is
18 amended to read as follows:

19 Section 1-118.1 The building fund of any technology center
20 school district shall consist of all monies derived from the
21 proceeds of a building fund levy ~~of~~ not to exceed five (5) mills in
22 any year, voted by the people of a school district pursuant to the
23 provisions of ~~Article X,~~ Section 10~~7~~, of Article X of the Oklahoma
24 Constitution, monies appropriated by the state for the purpose of
capital expenditures or projects, and monies donated to a school

1 district for the purpose of capital projects or improvements and may
2 be used for purchasing, providing, erecting, remodeling, repairing
3 or maintaining any of the following: school buildings, ~~for~~
4 ~~purchasing~~ furniture, computer systems and equipment and ~~computer,~~
5 software for instructional and noninstructional purposes, ~~for~~
6 ~~repairing and maintaining computer systems and equipment, for paying~~
7 energy and utility costs, ~~for purchasing~~ telecommunications
8 utilities and services, ~~for paying~~ fire and casualty insurance
9 premiums for school facilities, ~~for purchasing security systems, for~~
10 ~~paying salaries of security personnel,~~ student transportation,
11 grounds maintenance including parking lots and sidewalks,
12 instructional and maintenance equipment, or for one or more, or all,
13 of ~~such~~ these purposes. Proceeds of ~~such~~ the levies shall not be
14 required to be used during the year for which a levy is made but may
15 accumulate from year to year until adequate for the purposes
16 intended. The building fund ~~hereinabove~~ defined in this section is
17 hereby declared to be a current expense fund, but shall not be
18 considered a part of the general operating fund. No monies derived
19 from the proceeds of the school levies made pursuant to the
20 provisions of ~~Article X,~~ Section 9B of Article X of the Oklahoma
21 Constitution may be placed in the building fund provided by this
22 section.

23 SECTION 2. This act shall become effective July 1, 2012.

1 SECTION 3. It being immediately necessary for the preservation
2 of the public peace, health and safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
