11 An Act relating to roads, bridges and ferries;
12 designating the Samuel R. Henderson Memorial Bridge;
13 designating the PFC A.T. Howell Memorial Bridge;
14 designating the SSGT Billy Elliott Memorial Highway;
15 designating the SSG John R. Bush Memorial Bridge;
16 designating the Harold Bell Memorial Bridge;
17 designating Larry Wade Memorial Highway; designating
18 the USAF Maj. Aubrey Eugene Stowers, Jr. Memorial
19 Bridge; designating the Hannah Diggs Atkins Memorial
20 Highway; providing for placement of permanent
21 markers; providing for codification; and declaring an
22 emergency.

23 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

24 SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 1698.93 of Title 69, unless
there is created a duplication in numbering, reads as follows:

The bridge crossing the Washita River on State Highway 74 north
of Maysville shall be designated as the "Samuel R. Henderson

1 Memorial Bridge". The Department of Transportation shall cause
2 suitable permanent markers to be placed on the bridge bearing that
3 name.

4 SECTION 2. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 1698.94 of Title 69, unless
6 there is created a duplication in numbering, reads as follows:

7 The bridge crossing Leader Creek on State Highway 3 in Coal
8 County shall be designated as the "PFC A.T. Howell Memorial Bridge".
9 The Department of Transportation shall cause suitable permanent
10 markers to be placed on the bridge bearing that name.

11 SECTION 3. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 1698.95 of Title 69, unless
13 there is created a duplication in numbering, reads as follows:

14 The portion of U.S. Highway 59 extending from the Poteau River
15 Bridge to the Heavener city limits shall be designated as the "SSGT
16 Billy Elliott Memorial Highway". The Department of Transportation
17 shall cause suitable permanent markers to be placed on the highway
18 bearing that name.

19 SECTION 4. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 1698.96 of Title 69, unless
21 there is created a duplication in numbering, reads as follows:

22 The bridge crossing Sandy Creek on State Highway 99 in Pontotoc
23 County shall be designated as the "SSG John R. Bush Memorial
24

1 Bridge". The Department of Transportation shall cause suitable
2 permanent markers to be placed on the bridge bearing that name.

3 SECTION 5. NEW LAW A new section of law to be codified in
4 the Oklahoma Statutes as Section 1698.97 of Title 69, unless there
5 is created a duplication in numbering, reads as follows:

6 The bridge crossing Hudson Avenue on Interstate 244 in Tulsa
7 shall be designated as the "Harold Bell Memorial Bridge". The
8 Department of Transportation shall cause suitable permanent markers
9 to be placed on the bridge bearing that name.

10 SECTION 6. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 1698.98 of Title 69, unless
12 there is created a duplication in numbering, reads as follows:

13 The section of State Highway 6 in Beckham County from the
14 intersection of State Highway 6 and I-40 south to the intersection
15 of State Highway 6 and State Highway 152 shall be designated as the
16 "Larry Wade Memorial Highway". The Department of Transportation
17 shall cause suitable permanent markers to be placed on the highway
18 bearing that name.

19 SECTION 7. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 1698.99 of Title 69, unless
21 there is created a duplication in numbering, reads as follows:

22 The bridge located approximately three (3) miles west of
23 Sentinel on State Highway 55 in Washita County shall be designated
24 as the "USAF Maj. Aubrey Eugene Stowers, Jr. Memorial Bridge". The

1 Department of Transportation shall cause suitable permanent markers
2 to be placed on the bridge bearing that name.

3 SECTION 8. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.100 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The portion of Interstate 35 in Oklahoma City from Northeast
7 23rd Street extending north to the junction of Interstate 35 and
8 Interstate 44 shall be designated as the "Honorable Hannah Diggs
9 Atkins, Secretary of State, Memorial Highway". The Department of
10 Transportation shall cause suitable permanent markers to be placed
11 upon the highway bearing that name.

12 SECTION 9. It being immediately necessary for the preservation
13 of the public peace, health and safety, an emergency is hereby
14 declared to exist, by reason whereof this act shall take effect and
15 be in full force from and after its passage and approval.
