8 An Act relating to the Oklahoma Water Resources
9 Board; amending 82 O.S. 2001, Section 1085.7, which
10 relates to the Water Resources Board Revolving Fund;
11 modifying name of fund; creating the OWRB Revolving
12 Fund; providing for certain transfers; and providing
13 for codification.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 82 O.S. 2001, Section 1085.7, is
16 amended to read as follows:

17 Section 1085.7 All monies derived from fees shall be deposited
18 with the State Treasurer and credited, apportioned and appropriated
19 to a separate and distinct fund to be known as the Water Resources
20 Board Fee Revolving Fund to be used to enforce and administer the
21 water duties of the Oklahoma Water Resources Board, but no monies
22 shall be paid out of said Water Resources Board Fee Revolving Fund
23 until the claim therefor has been itemized and verified by claimant
24 and approved by the Oklahoma Water Resources Board and the Director
of the Office of State Finance as provided by law. When so

1 approved, the State Treasurer shall draw his warrant therefor upon
2 the State Treasurer and the same shall be paid out of the Water
3 Resources Board Fee Revolving Fund hereby created.

4 SECTION 2. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 1085.7B of Title 82, unless
6 there is created a duplication in numbering, reads as follows:

7 There is hereby created in the State Treasury a revolving fund
8 for the Oklahoma Water Resources Board to be designated the "OWRB
9 Revolving Fund". The fund shall be a continuing fund, not subject
10 to fiscal year limitations and shall consist of all monies collected
11 by the Oklahoma Water Resources Board which are not otherwise
12 designated. All monies accruing to the credit of the fund are
13 hereby appropriated and may be budgeted and expended by the Oklahoma
14 Water Resources Board for the purpose of duties imposed upon the
15 Oklahoma Water Resources Board by law.

16 SECTION 3. TRANSFER There is hereby transferred the
17 balance of the Statewide Water Development Revolving Fund created
18 pursuant to Section 1085.40 of Title 82 of the Oklahoma Statutes,
19 the balance of the Oklahoma Weather Modification Revolving Fund
20 created pursuant to Section 1087.6 of Title 82 of the Oklahoma
21 Statutes and the balance allowed in the Interagency Reimbursement
22 Fund (443 Fund), pursuant to Section 581 of Title 74 of the Oklahoma
23 Statutes to the OWRB Revolving Fund created in Section 2 of this
24 act.
