7 A Joint Resolution approving permanent rules of the  
8 Oklahoma Uniform Building Code Commission; and  
directing distribution.

10 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma  
11 Statutes, any rule which establishes or increases fees or any rule  
12 by an agency, board, or commission created by or that receives its  
13 authority from Title 59 of the Oklahoma Statutes shall require  
14 approval by the Legislature by joint resolution. If the Legislature  
15 fails to approve the rule on or before the last day of the  
16 legislative session, the rule shall be deemed disapproved; and

17 WHEREAS, the Oklahoma Uniform Building Code Commission cites the  
18 following authority for the rules adopted on March 20, 2012: Section  
19 1000.24 of Title 59 of the Oklahoma Statutes; and

20 WHEREAS, the permanent rules adopted by the Commission on March  
21 20, 2012, reflect the intent of the Oklahoma Legislature.

22 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES  
23 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

1 SECTION 1. The Legislature hereby approves the following  
2 permanent rules which were adopted by the Oklahoma Uniform Building
