

# An Act

An Act relating to game and fish; requiring every dealer to issue licenses by certain electronic means by a certain date; directing the Wildlife Conservation Commission to promulgate rules; repealing 29 O.S. 2001, Sections 4-201, as amended by Section 3, Chapter 35, O.S.L. 2007 and 4-202 (29 O.S. Supp. 2010, Section 4-201), which relate to licensing administration; providing for codification; and providing effective dates.

SUBJECT: Wildlife Conservation licensing administration

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 4-203 of Title 29, unless there is created a duplication in numbering, reads as follows:

A. Every dealer appointed to issue licenses as provided for in Section 3-202 of Title 29 of the Oklahoma Statutes shall be required to issue every license by means of an electronic point of sale system beginning no later than January 1, 2013.

B. By January 1, 2013, the Wildlife Conservation Commission shall promulgate rules establishing:

1. The duties of a dealer;
2. Procedures for issuing licenses and remitting license fees;

3. A collection fee to be retained by the dealer;
4. Reporting requirements;
5. Penalties for any violation of the rules; and
6. Any other rule deemed necessary by the Commission.

SECTION 2. REPEALER 29 O.S. 2001, Section 4-201, as amended by Section 3, Chapter 35, O.S.L. 2007 (29 O.S. Supp. 2010, Section 4-201), is hereby repealed.

SECTION 3. REPEALER 29 O.S. 2001, Section 4-202, is hereby repealed.

SECTION 4. Section 1 of this act shall become effective November 1, 2011.

SECTION 5. Sections 2 and 3 of this act shall become effective January 1, 2013.
