A Joint Resolution approving permanent rules of the State Board of Pharmacy; and directing distribution.

SUBJECT: State Board of Pharmacy rules

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, any rule which establishes or increases fees or any rule by an agency, board, or commission created by or that receives its authority from Title 59 of the Oklahoma Statutes shall require approval by the Legislature by joint resolution. If the Legislature fails to approve the rule on or before the last day of the legislative session, the rule shall be deemed disapproved; and

WHEREAS, pursuant to Sections 353.7, 353.13, 353.13A, 353.16A, 353.17, 353.18, 353.20, 353.22, 353.24, 353.26, 353.29 and 354 of Title 59 of the Oklahoma Statutes, the State Board of Pharmacy shall adopt the rules and regulations for the implementation of the provisions of the Oklahoma Pharmacy Act; and

WHEREAS, the permanent rules adopted by the Board on November 16, 2011, reflect the intent of the Oklahoma Legislature.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

SECTION 1. The Legislature hereby approves the following permanent rules which were adopted by the Board on November 16, 2011: OAC 535:1-11-1, 535:15-3-4.1, 535:15-3-17, 535:15-6-9,

535:15-16-1, 535:15-16-2, 535:15-16-3, 535:15-16-4, 535:15-16-5,  
535:15-16-6 and 535:15-16-7.

SECTION 2. The Secretary of State is directed to distribute copies of this resolution to the Governor, the State Board of Pharmacy, and the editor of "The Oklahoma Register".
