A Joint Resolution approving permanent rules of the Oklahoma Real Estate Commission; and directing distribution.

SUBJECT: Oklahoma Real Estate Commission rules

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, any rule which establishes or increases fees or any rule by an agency, board, or commission created by or that receives its authority from Title 59 of the Oklahoma Statutes shall require approval by the Legislature by joint resolution. If the Legislature fails to approve the rule on or before the last day of the legislative session, the rule shall be deemed disapproved; and

WHEREAS, pursuant to Section 858-208 of Title 59 of the Oklahoma Statutes, the Oklahoma Real Estate Commission shall promulgate rules, prescribe administrative fees by rule, and make orders as it may deem necessary or expedient in the performance of its duties; and

WHEREAS, the permanent rules adopted by the Oklahoma Real Estate Commission on March 14, 2012, reflect the intent of the Oklahoma Legislature.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

SECTION 1. The Legislature hereby approves the following permanent rules, which were adopted by the Oklahoma Real Estate

Commission on March 14, 2012: OAC 605:10-1-2, 605:10-1-3, 605:10-3-5, 605:10-3-7, 605:10-5-1, 605:10-5-1.1, 605:10-5-2, 605:10-7-2, 605:10-7-3, 605:10-7-4, 605:10-7-7, 605:10-7-8, 605:10-7-8.1, 605:10-7-8.2, 605:10-7-8.3, 605:10-7-8.4, 605:10-9-1, 605:10-9-4, 605:10-11-2, 605:10-11-3, 605:10-13-1, 605:10-15-3, 605:10-17-4, 605:10-17-6 and Appendix A.

SECTION 2. The Secretary of State is directed to distribute copies of this resolution to the Governor, the Oklahoma Real Estate Commission, and the editor of "The Oklahoma Register".
