A Joint Resolution approving permanent rules of the Oklahoma Uniform Building Code Commission; and directing distribution.

SUBJECT: Oklahoma Uniform Building Code Commission rules

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, any rule which establishes or increases fees or any rule by an agency, board, or commission created by or that receives its authority from Title 59 of the Oklahoma Statutes shall require approval by the Legislature by joint resolution. If the Legislature fails to approve the rule on or before the last day of the legislative session, the rule shall be deemed disapproved; and

WHEREAS, pursuant to Sections 1000.23 and 1000.29 of Title 59 of the Oklahoma Statutes, the Oklahoma Uniform Building Code Commission shall adopt the rules and regulations for the implementation of the provisions of the Oklahoma Uniform Building Code Commission Act; and

WHEREAS, the permanent rules adopted by the Commission on January 17, 2012, reflect the intent of the Oklahoma Legislature.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:
