WHEREAS, 4-H is the largest youth-serving organization in Oklahoma, reaching over 222,000 youth and 5,000 volunteers; it aids in the development of the Head, Heart, Hands and Health of every member; and

WHEREAS, 4-H as part of the Oklahoma Cooperative Extension Service provided by Langston University and Oklahoma State University, is a program whose mission is to help youth learn together through various kinds of projects, events and activities focusing around their mission mandates addressing Citizenship, Healthy Living, and Science, Technology, Engineering, and Mathematics; and

WHEREAS, members of the Oklahoma House of Representatives believe the achievement of these missions results in youth becoming capable, competent, and caring citizens who practice behaviors that will enable them to become self-directing, productive, and contributing members of society.
