An Act relating to endangered species; amending Section 1 of Enrolled Senate Bill No. 603 of the 1st Session of the 53rd Oklahoma Legislature, which relates to the Endangered Species and Economic Development Task Force; modifying membership; and declaring an emergency.

SUBJECT: Endangered species and economic development task force

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 1 of Enrolled Senate Bill No. 603 of the 1st Session of the 53rd Oklahoma Legislature, is amended to read as follows:

Section 1. A. There is hereby created until December 31, 2011, the Endangered Species and Economic Development Task Force to assist agencies in providing policy and technical assistance regarding compliance with endangered species laws. The task force shall:

1. Assess the economic impact on the state of federal, state, or local regulations relating to endangered species;

2. Assist landowners and other persons in this state to identify, evaluate, and implement cost-efficient strategies for mitigation of impacts to and recovery of endangered species that will promote economic growth and development in this state;

3. Facilitate state agencies and local governmental efforts to effectively implement endangered species regulations in a cost efficient manner;

4. Make recommendations, if requested by a local government or a state official, addressing endangered species issues; and

5. Work in coordination with the United States Fish and Wildlife Service, institutions of higher education, and agriculture and conservation organizations in performing its functions and duties.

B. The task force shall be composed of ~~nine (9)~~ ten (10) members as follows:

1. One member of the Senate appointed by the President Pro Tempore of the Senate or designee;

2. One member of the House of Representatives appointed by the Speaker of the House of Representatives or designee;

3. The Secretary of Commerce and Tourism or designee;

4. The Secretary of Environment or designee;

5. The Secretary of Agriculture or designee;

6. The chair of the Corporation Commission or designee;

7. The State Wildlife Conservation Director or designee;

8. The Director of the Oklahoma Association of Conservation Districts or designee; ~~and~~

9. ~~The Director of the Department~~ Secretary of Transportation or designee; and

10. The Secretary of Energy or designee.

C. The appointed members of the task force shall serve at the pleasure of the appointing authority.

D. The chair of the task force shall be the Secretary of Commerce and Tourism and the vice-chair shall be selected from the members of the task force.

E. A majority of the members of the task force shall constitute a quorum for the purpose of taking any action.

F. Staff support of the task force shall be provided by the Oklahoma Department of Commerce.

G. The task force shall provide reports as needed on:

1. Innovative programs to address endangered species issues while promoting economic growth; and

2. Legislative recommendations to the President Pro Tempore of the Senate, the Speaker of the House of Representatives, and the Governor by December 31, 2011.

SECTION 2. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
