7 AS INTRODUCED

8 A Concurrent Resolution disapproving a certain
9 capital project submitted by the Oklahoma State
10 Regents for Higher Education for legislative review
11 pursuant to the master lease program; and directing
12 distribution.

14 WHEREAS, Section 3206.6a of Title 70 of the Oklahoma Statutes
15 authorizes the Oklahoma State Regents for Higher Education to
16 finance acquisition of or improvements to, or refinance or
17 restructure outstanding obligations for real property pursuant to
18 the master lease program established by the Legislature in Section
19 3206.6 of Title 70 of the Oklahoma Statutes; and

20 WHEREAS, Section 3206.6a of Title 70 of the Oklahoma Statutes
21 requires the Oklahoma State Regents for Higher Education to submit
22 an itemized list of the proposed projects and the terms of the
23 financing to the Governor, the Speaker of the House of

1 Representatives and the President Pro Tempore of the Senate within
2 the first seven (7) legislative days of an annual legislative
3 session and prior to the time any such obligations are sold; and

4 WHEREAS, Section 3206.6a of Title 70 of the Oklahoma Statutes
5 provides that the Legislature shall have a period of forty-five (45)
6 calendar days from the date on which the information is submitted to
7 pass a concurrent resolution disapproving all or part of the
8 proposed issuance; and

9 WHEREAS, the Oklahoma State Regents for Higher Education
10 submitted an itemized list of thirty-three proposed capital projects
11 from fourteen state institutions and the terms of the financing for
12 review to the Governor, the Speaker of the House of Representatives
13 and the President Pro Tempore of the Senate; and

14 WHEREAS, said list was received by all parties on February 6,
15 2012.

16 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
17 OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE, THE SENATE
18 CONCURRING THEREIN:

19 THAT pursuant to the authority provided in Section 3206.6a of
20 Title 70 of the Oklahoma Statutes, the Legislature hereby
21 disapproves the Medical Examiner's Facility Project proposed by the
22 University of Central Oklahoma which appears on the list submitted
23 by the Oklahoma State Regents for Higher Education.

1 THAT the Secretary of State is hereby directed to distribute
2 copies of this resolution to the Chancellor of The Oklahoma State
3 System of Higher Education and to the Oklahoma State Regents for
4 Higher Education.
