10 A Concurrent Resolution congratulating Miss Anna-
11 Marie Ahrberg upon her selection as the Distinguished
12 Young Woman of Oklahoma for 2012; wishing her the
13 best for further competition; and directing

16 WHEREAS, the Distinguished Young Women of Oklahoma Scholarship
17 Program is held annually to honor the best and brightest high school
18 senior girls in Oklahoma. This statewide program recognizes,
19 rewards, and encourages outstanding young women who have
20 distinguished themselves at school and in their communities. The
21 Distinguished Young Women of Oklahoma Scholarship Program selection
22 for 2012 occurred on July 23, 2011, at the Bartlesville Community

3 WHEREAS, Miss Anna-Marie Ahrberg, daughter of William and Jo
4 Ahrberg of Cushing, was selected as the Distinguished Young Woman of
5 Oklahoma for 2012, and was awarded a total of \$1,900.00 in college
6 scholarships; and

7 WHEREAS, while holding the title of Distinguished Young Woman of
8 Oklahoma for 2012, Miss Ahrberg will be involved in community
9 service, speaking and performing engagements across the State of
10 Oklahoma, and presenting her "Be Your Best Self" message of Self-
11 Confidence and Commitment to Oklahoma's school children, encouraging
12 young people to: Be Involved, Be Studious, Be Healthy, Be Ambitious,
13 and Be Responsible; and

14 WHEREAS, Miss Ahrberg will represent Oklahoma in the 55th Annual
15 Distinguished Young Women of America National Finals to be held June
16 28-30, 2012, in Mobile, Alabama, and will compete for a share of
17 more than \$140,000.00 in college scholarships.
