8                                   AS INTRODUCED

9                   A Joint Resolution approving permanent rules of the  
10 Department of Human Services; and directing  
11 distribution.

13                   WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma  
14 Statutes, any rule which establishes or increases fees or any rule  
15 by an agency, board, or commission created by or that receives its  
16 authority from Title 59 of the Oklahoma Statutes shall require  
17 approval by the Legislature by joint resolution. If the Legislature  
18 fails to approve the rule on or before the last day of the  
19 legislative session, the rule shall be deemed disapproved; and

20                   WHEREAS, the Commission for Human Services cites the following  
21 authority for the rules adopted on February 28, 2012: Sections 2 and  
22 4 of Article XXV of the Oklahoma Constitution; Sections 653, 654,  
23 654a and 654b of Title 42 of the United States Code; Section 1738B

1 of Title 28 of the United States Code; Sections 302.32, 302.33,  
2 302.38, 302.60, 302.70, 303.6, 303.72, 307.11 and 307.13 of Title 45  
3 of the Code of Federal Regulations; and Sections 205.2 and 205.3 of  
4 Title 68 of the Oklahoma Statutes; and

5 WHEREAS, the permanent rules adopted by the Commission for Human  
6 Services on February 28, 2012, reflect the intent of the Oklahoma  
7 Legislature.

8 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES  
9 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

10 SECTION 1. The Legislature hereby approves permanent rules OAC  
11 340:25-5-215, 340:25-5-215.1 and 340:25-5-235, which were adopted by  
12 the Commission for Human Services on February 28, 2012.

13 SECTION 2. The Secretary of State is directed to distribute  
14 copies of this resolution to the Governor, the Department of Human  
15 Services, and the editor of "The Oklahoma Register".
