8 AS INTRODUCED

9 A Joint Resolution approving permanent rules of the
10 Oklahoma Real Estate Commission; and directing
11 distribution.

13 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma
14 Statutes, any rule which establishes or increases fees or any rule
15 by an agency, board, or commission created by or that receives its
16 authority from Title 59 of the Oklahoma Statutes shall require
17 approval by the Legislature by joint resolution. If the Legislature
18 fails to approve the rule on or before the last day of the
19 legislative session, the rule shall be deemed disapproved; and

20 WHEREAS, pursuant to Section 858-208 of Title 59 of the Oklahoma
21 Statutes, the Oklahoma Real Estate Commission shall promulgate
22 rules, prescribe administrative fees by rule, and make orders as it

1 may deem necessary or expedient in the performance of its duties;
2 and

3 WHEREAS, the permanent rules adopted by the Oklahoma Real Estate
4 Commission on March 14, 2012, reflect the intent of the Oklahoma
5 Legislature.

6 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
7 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

8 SECTION 1. The Legislature hereby approves the following
9 permanent rules, which were adopted by the Oklahoma Real Estate
10 Commission on March 14, 2012: OAC 605:10-1-2, 605:10-1-3, 605:10-3-
11 5, 605:10-3-7, 605:10-5-1, 605:10-5-1.1, 605:10-5-2, 605:10-7-2,
12 605:10-7-3, 605:10-7-4, 605:10-7-7, 605:10-7-8, 605:10-7-8.1,
13 605:10-7-8.2, 605:10-7-8.3, 605:10-7-8.4, 605:10-9-1, 605:10-9-4,
14 605:10-11-2, 605:10-11-3, 605:10-13-1, 605:10-15-3, 605:10-17-4,
15 605:10-17-6 and Appendix A.
