8 AS INTRODUCED

9 A Joint Resolution approving permanent rules of the
10 State Board of Licensed Social Workers; and directing
11 distribution.

13 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma
14 Statutes, any rule which establishes or increases fees or any rule
15 by an agency, board, or commission created by or that receives its
16 authority from Title 59 of the Oklahoma Statutes shall require
17 approval by the Legislature by joint resolution. If the Legislature
18 fails to approve the rule on or before the last day of the
19 legislative session, the rule shall be deemed disapproved; and

20 WHEREAS, the State Board of Licensed Social Workers cites the
21 following authority for the rules adopted on January 20, 2012:
22 Sections 1256.1 and 1261.1 of Title 59 of the Oklahoma Statutes; and

1 WHEREAS, the permanent rules adopted by the Board on January 20,
2 2012, reflect the intent of the Oklahoma Legislature.

3 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
4 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

5 SECTION 1. The Legislature hereby approves the following
6 permanent rules which were adopted by the State Board of Licensed
7 Social Workers on January 20, 2012: OAC 675:1-1-1.1, 675:1-1-4,
8 675:1-1-9, 675:3-1-2, 675:3-1-3, 675:3-1-3.1, 675:3-1-4, 675:10-1-
9 1.2, 675:10-1-4, 675:10-1-5, 675:10-1-6, 675:10-1-9, 675:10-1-10,
10 675:10-1-12.1, 675:12-1-4, 675:12-1-6, 675:12-1-8, 675:15-1-2,
11 675:15-1-3, 675:15-1-5 and 675:20-1-6.

12 SECTION 2. The Secretary of State is directed to distribute
13 copies of this resolution to the Governor, the State Board of
14 Licensed Social Workers, and the editor of "The Oklahoma Register".
