11 A Joint Resolution approving permanent rule of the
12 Corporation Commission; and directing distribution.

15 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma
16 Statutes, any rule which establishes or increases fees or any rule
17 by an agency, board, or commission created by or that receives its
18 authority from Title 59 of the Oklahoma Statutes shall require
19 approval by the Legislature by joint resolution. If the Legislature
20 fails to approve the rule on or before the last day of the
21 legislative session, the rule shall be deemed disapproved; and

22 WHEREAS, the Corporation Commission cites the following
23 authority for the rules adopted on March 16, 2012: Sections 52, 152,

1 166.1 and subsection A of Section 166.1a of Title 17 of the Oklahoma
2 Statutes, Section 1-3-101 of Title 27A of the Oklahoma Statutes,
3 Sections 177.2, 230.24, 230.34a, 1124 and 1124.2 of Title 47 of the
4 Oklahoma Statutes, paragraph 3 of Section 24A.5 of Title 51 of the
5 Oklahoma Statutes, Sections 87.6 through 87.9 and 139 of Title 52 of
6 the Oklahoma Statutes, Section 607 of Title 68 of the Oklahoma
7 Statutes, and Section 18 of Article IX of the Oklahoma Constitution;

9 WHEREAS, the permanent rule adopted by the Commission on March
10 16, 2012, reflects the intent of the Oklahoma Legislature.

11 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
12 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

13 SECTION 1. The Legislature hereby approves the following
14 permanent rule which was adopted by the Corporation Commission on
15 March 16, 2012: OAC 165:5-3-1.

16 SECTION 2. The Secretary of State is directed to distribute
17 copies of this resolution to the Governor, the Corporation
18 Commission, and the editor of "The Oklahoma Register".
