9                                   AS INTRODUCED

10                   A Joint Resolution approving permanent rules of the  
11                   Oklahoma Uniform Building Code Commission; and  
12                   directing distribution.

14                   WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma  
15                   Statutes, any rule which establishes or increases fees or any rule  
16                   by an agency, board, or commission created by or that receives its  
17                   authority from Title 59 of the Oklahoma Statutes shall require  
18                   approval by the Legislature by joint resolution. If the Legislature  
19                   fails to approve the rule on or before the last day of the  
20                   legislative session, the rule shall be deemed disapproved; and

21                   WHEREAS, the Oklahoma Uniform Building Code Commission cites the  
22                   following authority for the rules adopted on March 20, 2012: Section  
23                   1000.24 of Title 59 of the Oklahoma Statutes; and

1 WHEREAS, the permanent rules adopted by the Commission on March  
2 20, 2012, reflect the intent of the Oklahoma Legislature.

3 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES  
4 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

5 SECTION 1. The Legislature hereby approves the following  
6 permanent rules which were adopted by the Oklahoma Uniform Building  
7 Code Commission on March 20, 2012: OAC 748:1-1-2, 748:1-1-4, 748:3-
