18 Memorial Commission, the Department of Labor, the  
19 Department of Mines, the Scenic Rivers Commission,  
20 the Oklahoma Tourism and Recreation Department, the  
21 Oklahoma Water Resources Board, the Will Rogers  
22 Memorial Commission, the Alcoholic Beverage Laws  
23 Enforcement Commission, the Department of  
24 Corrections, the Office of the State Fire Marshal,  
the Oklahoma State Bureau of Investigation, the  
Council on Law Enforcement Education and Training,  
the Board of Medicolegal Investigations, the Oklahoma  
State Bureau of Narcotics and Dangerous Drugs  
Control, the Department of Public Safety, the Office  
of the Attorney General, the Court of Criminal  
Appeals, district attorneys and the District  
Attorneys Council, the Supreme Court, the Oklahoma  
Indigent Defense System, the Pardon and Parole Board  
and the Workers' Compensation Court; stating amounts  
of the appropriations; stating purposes and  
restrictions; authorizing and requiring certain  
expenditures; authorizing and requiring certain  
transfers; requiring certain deposit; and providing  
effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

1 SECTION 1. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2013, the sum of One Billion Seven Million Three  
5 Hundred Fourteen Thousand Eighty-one Dollars (\$1,007,314,081.00) or  
6 so much thereof as may be necessary for the financial support of  
7 public schools.

8 SECTION 2. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Education Reform Revolving Fund created in Section 34.89 of Title 62  
11 of the Oklahoma Statutes, the sum of Seven Hundred Twenty-six  
12 Million One Hundred Sixty-two Thousand Five Hundred Thirty Dollars  
13 (\$726,162,530.00) or so much thereof as may be necessary for the  
14 financial support of public schools.

15 SECTION 3. The State Board of Education is hereby authorized to  
16 expend during the fiscal year ending June 30, 2013, from the Common  
17 Education Technology Revolving Fund of the State Treasury, the sum  
18 of Forty-seven Million Three Hundred Seventy-two Thousand Two  
19 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as  
20 may be necessary for the financial support of public schools.

21 SECTION 4. There is hereby appropriated to the State Board of  
22 Education from any monies not otherwise appropriated from the  
23 Mineral Leasing Fund of the State Treasury for the fiscal year  
24 ending June 30, 2013, the sum of Three Million Eight Hundred

1 Thousand Dollars (\$3,800,000.00) or so much thereof as may be  
2 necessary for the financial support of public schools.

3 SECTION 5. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
6 fiscal year ending June 30, 2013, the sum of Twenty-five Million  
7 Eight Hundred Seventy-three Thousand Three Hundred Five Dollars  
8 (\$25,873,305.00) or so much thereof as may be necessary for the  
9 financial support of public schools.

10 SECTION 6. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
13 fiscal year ending June 30, 2011, the sum of Three Million Five  
14 Hundred Twenty-nine Thousand Five Hundred Ten Dollars  
15 (\$3,529,510.00) or so much thereof as may be necessary for the  
16 financial support of public schools.

17 SECTION 7. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Special Cash Fund of the State Treasury, the sum of One Million Four  
20 Hundred Sixty-three Thousand One Hundred Twenty-seven Dollars  
21 (\$1,463,127.00) or so much thereof as may be necessary for the  
22 financial support of public schools.

23 SECTION 8. There is hereby appropriated to the State Board of  
24 Education from any monies not otherwise appropriated from the

1 Mineral Leasing Fund of the State Treasury for the fiscal year  
2 ending June 30, 2011, the sum of Five Hundred Seventy-six Thousand  
3 Five Hundred Three Dollars (\$576,503.00) or so much thereof as may  
4 be necessary for the financial support of public schools.

5 SECTION 9. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 General Revenue Fund of the State Treasury for the fiscal year  
8 ending June 30, 2013, the sum of Two Hundred Twenty-six Million  
9 Eight Hundred Forty-two Thousand Eight Hundred Thirty-three Dollars  
10 (\$226,842,833.00) or so much thereof as may be necessary to provide  
11 funding for the Certified Employee Health Benefit Allowance.

12 SECTION 10. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 General Revenue Fund of the State Treasury for the fiscal year  
15 ending June 30, 2013, the sum of One Hundred Seventeen Million Three  
16 Hundred Twenty-one Thousand One Hundred Forty-eight Dollars  
17 (\$117,321,148.00) or so much thereof as may be necessary to provide  
18 funding for the Support Personnel Health Benefit Allowance.

19 SECTION 11. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 General Revenue Fund of the State Treasury for the fiscal year  
22 ending June 30, 2013, the sum of Eleven Million Six Hundred Ninety-  
23 five Thousand Dollars (\$11,695,000.00) or so much thereof as may be  
24 necessary to provide an annual bonus for those teachers possessing

1 National Board Certification as provided for in Section 6-204 et  
2 seq. of Title 70 of the Oklahoma Statutes.

3 SECTION 12. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2013, the sum of Three Million Two Hundred Forty-  
7 seven Thousand Three Hundred Fifty Thousand Dollars (\$3,247,350.00)  
8 or so much thereof as may be necessary to provide an annual bonus  
9 for school psychologists, speech-language pathologists, and  
10 audiologists as directed in Section 6-206 of Title 70 of the  
11 Oklahoma Statutes.

12 SECTION 13. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 General Revenue Fund of the State Treasury for the fiscal year  
15 ending June 30, 2013, the sum of Fourteen Million Eight Hundred  
16 Seventy-seven Thousand Three Hundred Sixty-six Dollars  
17 (\$14,877,366.00) or so much thereof as may be necessary for the  
18 purpose of operating the statewide system of alternative education  
19 programs as provided in Section 1210.568 of Title 70 of the Oklahoma  
20 Statutes.

21 SECTION 14. There is hereby appropriated to the State Board of  
22 Education from any monies not otherwise appropriated from the  
23 General Revenue Fund of the State Treasury for the fiscal year  
24 ending June 30, 2013, the sum of Six Million Nine Hundred Fifty-two

1 Thousand Eight Hundred Sixty-nine Dollars (\$6,952,869.00) or so much  
2 thereof as may be necessary to implement the provisions of Enrolled  
3 Senate Bill No. 346 of the 1st Session of the 53rd Oklahoma  
4 Legislature and the provisions of Enrolled House Bill No. 1456 of  
5 the 1st Session of the 53rd Oklahoma Legislature.

6 SECTION 15. There is hereby appropriated to the State Board of  
7 Education from any monies not otherwise appropriated from the  
8 General Revenue Fund of the State Treasury for the fiscal year  
9 ending June 30, 2013, the sum of Fourteen Million Four Hundred  
10 Seventeen Thousand Nine Hundred Twenty-two Dollars (\$14,417,922.00)  
11 or so much thereof as may be necessary for SoonerStart Early  
12 Intervention Services.

13 SECTION 16. There is hereby appropriated to the State Board of  
14 Education from any monies not otherwise appropriated from the  
15 General Revenue Fund of the State Treasury for the fiscal year  
16 ending June 30, 2013, the sum of Ten Million Dollars  
17 (\$10,000,000.00) or so much thereof as may be necessary for the  
18 purpose of funding the early childhood program pursuant to the  
19 provisions of Section 10-105.4 of Title 70 of the Oklahoma Statutes.

20 SECTION 17. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 General Revenue Fund of the State Treasury for the fiscal year  
23 ending June 30, 2013, the sum of Four Million Nine Hundred Sixty  
24 Thousand Two Hundred Eighty-eight Dollars (\$4,960,288.00) or so much

1 thereof as may be necessary for School Lunch Matching and School  
2 Lunch Programs.

3 SECTION 18. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2013, the sum of Thirty-five Million Three Hundred  
7 Eleven Thousand Three Hundred Seventy-five Dollars (\$35,311,375.00)  
8 or so much thereof as may be necessary for the purpose of funding  
9 the Teachers' Retirement Credit as provided for in Section 17-108.2  
10 of Title 70 of Oklahoma Statutes.

11 SECTION 19. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 General Revenue Fund of the State Treasury for the fiscal year  
14 ending June 30, 2013, the sum of Seven Million Nine Hundred Twenty-  
15 five Thousand Nine Hundred Seventy-four Dollars (\$7,925,974.00) or  
16 so much thereof as may be necessary for the support of public  
17 schools activities. Of the funds appropriated in this section, One  
18 Hundred Eighty-five Thousand Dollars (\$185,000.00) shall be used for  
19 a Truancy Division Program in a large urban county selected by the  
20 State Department of Education.

21 SECTION 20. There is hereby appropriated to the State Board of  
22 Education from any monies not otherwise appropriated from the  
23 General Revenue Fund of the State Treasury for the fiscal year  
24 ending June 30, 2011, the sum of Thirty-three Million Dollars

1 (\$33,000,000.00) or so much thereof as may be necessary for the  
2 support of public schools activities.

3 SECTION 21. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2013, the sum of Twenty-one Million Four Hundred  
7 Twenty-six Thousand Six Hundred Forty-two Dollars (\$21,426,642.00)  
8 or so much thereof as may be necessary for administrative and  
9 support functions of the State Department of Education.

10 SECTION 22. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
13 fiscal year ending June 30, 2013, the sum of Two Million Eight  
14 Hundred Seventy-four Thousand Eight Hundred Twelve Dollars  
15 (\$2,874,812.00) or so much thereof as may be necessary for transfer  
16 to the School Consolidation Assistance Fund.

17 SECTION 23. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
20 fiscal year ending June 30, 2011, the sum of Three Hundred Ninety-  
21 two Thousand One Hundred Sixty-eight Dollars (\$392,168.00) or so  
22 much thereof as may be necessary for transfer to the School  
23 Consolidation Assistance Fund.

1 SECTION 24. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
4 fiscal year ending June 30, 2013, the sum of Two Million Eight  
5 Hundred Seventy-four Thousand Eight Hundred Twelve Dollars  
6 (\$2,874,812.00) or so much thereof as may be necessary for transfer  
7 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

8 SECTION 25. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2011, the sum of Three Hundred Ninety-  
12 two Thousand One Hundred Sixty-eight Dollars (\$392,168.00) or so  
13 much thereof as may be necessary for transfer to the Teachers'  
14 Retirement System Dedicated Revenue Revolving Fund.

15 SECTION 26. There is hereby appropriated to the Oklahoma Arts  
16 Council from any monies not otherwise appropriated from the General  
17 Revenue Fund of the State Treasury for the fiscal year ending June  
18 30, 2013, the sum of Four Million Ten Thousand Eighty-seven Dollars  
19 (\$4,010,087.00) or so much thereof as may be necessary to perform  
20 the duties imposed upon the Oklahoma Arts Council by law.

21 SECTION 27. There is hereby appropriated to the State Board of  
22 Career and Technology Education from any monies not otherwise  
23 appropriated from the General Revenue Fund of the State Treasury for  
24 the fiscal year ending June 30, 2013, the sum of One Hundred Thirty-

1 one Million Five Hundred Forty-eight Thousand Nine Hundred Forty  
2 Dollars (\$131,548,940.00) or so much thereof as may be necessary to  
3 perform the duties imposed upon the State Board of Career and  
4 Technology Education by law.

5 SECTION 28. There is hereby appropriated to the State Board of  
6 Career and Technology Education from any monies not otherwise  
7 appropriated from the Oklahoma Education Lottery Trust Fund of the  
8 State Treasury for the fiscal year ending June 30, 2013, the sum of  
9 Three Million One Hundred Sixty-two Thousand Two Hundred Ninety-  
10 three Dollars (\$3,162,293.00) pursuant to paragraph 2 of subsection  
11 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation  
12 by the State Board of Career and Technology Education for the  
13 education and general operating budgets of the institutions and for  
14 other programs, construction, renovations or repairs administered by  
15 the State Board of Career and Technology Education.

16 SECTION 29. There is hereby appropriated to the State Board of  
17 Career and Technology Education from any monies not otherwise  
18 appropriated from the Oklahoma Education Lottery Trust Fund of the  
19 State Treasury for the fiscal year ending June 30, 2011, the sum of  
20 Four Hundred Thirty-one Thousand Three Hundred Eighty-five Dollars  
21 (\$431,385.00) pursuant to paragraph 2 of subsection C of Section 713  
22 of Title 3A of the Oklahoma Statutes for allocation by the State  
23 Board of Career and Technology Education for the education and  
24 general operating budgets of the institutions and for other

1 programs, construction, renovations or repairs administered by the  
2 State Board of Career and Technology Education.

3 SECTION 30. There is hereby appropriated to the Commissioners  
4 of the Land Office from any monies not otherwise appropriated from  
5 the Commissioners of the Land Office Fund of the State Treasury for  
6 the fiscal year ending June 30, 2013, the sum of Sixteen Million  
7 Dollars (\$16,000,000.00) or so much thereof as may be necessary to  
8 perform the duties imposed upon the Commissioners of the Land Office  
9 by law. Of those funds appropriated, the sum of Eight Million Twenty  
10 Thousand Dollars (\$8,020,000.00) shall be deposited in the  
11 Commissioners of the Land Office Revolving Fund created pursuant to  
12 Section 1009 of Title 64 of the Oklahoma Statutes.

13 SECTION 31. There is hereby appropriated to the Oklahoma  
14 Educational Television Authority from any monies not otherwise  
15 appropriated from the General Revenue Fund of the State Treasury for  
16 the fiscal year ending June 30, 2013, the sum of Three Million Eight  
17 Hundred Twenty-two Thousand Three Hundred Twenty-eight Dollars  
18 (\$3,822,328.00) or so much thereof as may be necessary to perform  
19 the duties imposed upon the Oklahoma Educational Television  
20 Authority by law.

21 SECTION 32. There is hereby appropriated to the Oklahoma State  
22 Regents for Higher Education from any monies not otherwise  
23 appropriated from the General Revenue Fund of the State Treasury for  
24 the fiscal year ending June 30, 2013, the sum of Seven Hundred

1 Sixty-two Million Nine Hundred Eight Thousand Two Hundred Ninety-  
2 five Dollars (\$762,908,295.00) or so much thereof as may be  
3 necessary for allocation by the Oklahoma State Regents for Higher  
4 Education pursuant to the provisions of Article XIII-a of the  
5 Oklahoma Constitution for the education and general operating  
6 budgets of the institutions and for other programs, construction,  
7 renovations or repairs administered by the Oklahoma State Regents  
8 for Higher Education. Of those funds appropriated, the sum of Three  
9 Million Eight Hundred Thirty Thousand Thirty-eight Dollars  
10 (\$3,830,038.00) shall be transferred to the Oklahoma Tuition  
11 Equalization Grant Trust Fund to implement the provisions of the  
12 Oklahoma Tuition Equalization Grant Act.

13 SECTION 33. The Oklahoma State Regents for Higher Education are  
14 hereby authorized to expend during the fiscal year ending June 30,  
15 2013, the sum of Forty-seven Million Three Hundred Seventy-two  
16 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the  
17 Higher Education Capital Revolving Fund of the State Treasury for  
18 allocation by the Oklahoma State Regents for Higher Education  
19 pursuant to the provisions of Article XIII-a of the Oklahoma  
20 Constitution for the education and general operating budgets of the  
21 institutions and for other programs, construction, renovations or  
22 repairs administered by the Oklahoma State Regents for Higher  
23 Education.

24

1 SECTION 34. The Oklahoma State Regents for Higher Education are  
2 hereby authorized to expend during the fiscal year ending June 30,  
3 2013, the sum of Forty-seven Million Three Hundred Seventy-two  
4 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the  
5 Oklahoma Student Aid Revolving Fund of the State Treasury for  
6 allocation by the Oklahoma State Regents for Higher Education  
7 pursuant to the provisions of Article XIII-a of the Oklahoma  
8 Constitution for the education and general operating budgets of the  
9 institutions and for other programs, construction, renovations or  
10 repairs administered by the Oklahoma State Regents for Higher  
11 Education.

12 SECTION 35. There is hereby appropriated to the Oklahoma State  
13 Regents for Higher Education from any monies not otherwise  
14 appropriated from the Special Cash Fund of the State Treasury the  
15 sum of Sixty-five Million Dollars (\$65,000,000.00) for allocation by  
16 the Oklahoma State Regents for Higher Education pursuant to the  
17 provisions of Article XIII-a of the Oklahoma Constitution for the  
18 education and general operating budgets of the institutions and for  
19 other programs, construction, renovations or repairs administered by  
20 the Oklahoma State Regents for Higher Education.

21 SECTION 36. There is hereby appropriated to the Oklahoma State  
22 Regents for Higher Education from any monies not otherwise  
23 appropriated from the proceeds of the sale of bonds deposited in the  
24 Oklahoma Building Bonds of 1992 Fund A in the State Treasury, the

1 sum of One Hundred Seventy-nine Dollars (\$179.00) or so much thereof  
2 as may be necessary for allocation by the Oklahoma State Regents for  
3 Higher Education pursuant to the provisions of Article XIII-a of the  
4 Oklahoma Constitution for the education and general operating  
5 budgets of the institutions and for other programs, construction,  
6 renovations or repairs administered by the Oklahoma State Regents  
7 for Higher Education.

8 SECTION 37. There is hereby appropriated to the Oklahoma State  
9 Regents for Higher Education from any monies not otherwise  
10 appropriated from the proceeds of the sale of bonds deposited in the  
11 Oklahoma Building Bonds of 1992 Fund B in the State Treasury, the  
12 sum of Seventy-three Dollars (\$73.00) or so much thereof as may be  
13 necessary for allocation by the Oklahoma State Regents for Higher  
14 Education pursuant to the provisions of Article XIII-a of the  
15 Oklahoma Constitution for the education and general operating  
16 budgets of the institutions and for other programs, construction,  
17 renovations or repairs administered by the Oklahoma State Regents  
18 for Higher Education.

19 SECTION 38. There is hereby appropriated to the Oklahoma State  
20 Regents for Higher Education from any monies not otherwise  
21 appropriated from the General Revenue Fund of the State Treasury for

8 One Million Five Hundred One Thousand Three Hundred Seventy-five  
9 Dollars (\$1,501,375.00) is authorized to be transferred from the  
10 Crime Victims Compensation Revolving Fund, created by Section 142.17  
11 of Title 21 of the Oklahoma Statutes, to the District Attorneys  
12 Council for duties to support Victim-witness Services.

13 SECTION 137. There is hereby appropriated to the Court of  
14 Criminal Appeals from any monies not otherwise appropriated from the  
15 General Revenue Fund of the State Treasury for the fiscal year  
16 ending June 30, 2013, the sum of Three Million Four Hundred Eighty-  
17 four Thousand Six Hundred Thirty-one Dollars (\$3,484,631.00) or so  
18 much thereof as may be necessary to perform the duties imposed upon  
19 the Court of Criminal Appeals by law.

20 SECTION 138. There is hereby appropriated to the Supreme Court  
21 from any monies not otherwise appropriated from the General Revenue  
22 Fund of the State Treasury for the fiscal year ending June 30, 2013,  
23 the sum of Seventeen Million Three Hundred Thirty-seven Thousand  
24 Dollars (\$17,337,000.00) or so much thereof as may be necessary to

1 perform the duties imposed upon the Supreme Court or Court of Civil  
2 Appeals by law.

3 SECTION 139. For the fiscal year ending June 30, 2013, the  
4 Office of State Finance shall, at the request of the Administrative  
5 Director of the Courts, transfer from the Lengthy Trial Fund to the  
6 Supreme Court Administrative Revolving Fund an amount not to exceed  
7 Two Million Dollars (\$2,000,000.00) that the Administrative Director  
8 of the Courts, with the approval of the Chief Justice of the Supreme  
9 Court in his or her sole discretion, shall deem appropriate or  
10 necessary including, but not limited to, appellate and district  
11 court expenditures.

12 SECTION 140. The Supreme Court is hereby authorized to expend  
13 during the fiscal year ending June 30, 2013, from the State Judicial  
14 Revolving Fund of the State Treasury, the sum of Fifty-one Million  
15 Dollars (\$51,000,000.00) or so much thereof as may be necessary for  
16 the financial support of the District Courts.

17 SECTION 141. There is hereby appropriated to the Supreme Court  
18 from any monies not otherwise appropriated from the General Revenue  
19 Fund of the State Treasury for the fiscal year ending June 30, 2013,  
20 the sum of Eight Million Six Hundred Thousand Dollars  
21 (\$8,600,000.00) or so much thereof as may be necessary to perform  
22 the duties imposed upon the District Courts by law.

23 SECTION 142. There is hereby appropriated to the Workers'  
24 Compensation Court from any monies not otherwise appropriated from

1 the General Revenue Fund of the State Treasury for the fiscal year  
2 ending June 30, 2013, the sum of Four Million Two Hundred Forty-  
3 seven Thousand One Hundred Sixty-six Dollars (\$4,247,166.00) or so  
4 much thereof as may be necessary to perform the duties imposed upon  
5 the Workers' Compensation Court by law.

6 SECTION 143. There is hereby appropriated to the Oklahoma  
7 Indigent Defense System from any monies not otherwise appropriated  
8 from the General Revenue Fund of the State Treasury for the fiscal  
9 year ending June 30, 2013, the sum of Fourteen Million Six Hundred  
10 Ninety-nine Thousand Three Hundred Fifty-three Dollars  
11 (\$14,699,353.00) or so much thereof as may be necessary to perform  
12 the duties imposed upon the Oklahoma Indigent Defense System by law.

13 SECTION 144. There is hereby appropriated to the Department of  
14 Corrections from any monies not otherwise appropriated from the  
15 Special Cash Fund of the State Treasury, the sum of Twenty Million  
16 Dollars (\$20,000,000.00) or so much thereof as may be necessary to  
17 perform the duties imposed upon the Department of Corrections by  
18 law.

19 SECTION 145. There is hereby appropriated to the Department of  
20 Corrections from any monies not otherwise appropriated from the  
21 General Revenue Fund of the State Treasury for the fiscal year  
22 ending June 30, 2013, the sum of Four Hundred Forty-three Million  
23 Seven Hundred Thirty-one Thousand Sixty-eight Dollars

1 (\$443,731,068.00) or so much thereof as may be necessary to perform  
2 the duties imposed upon the Department of Corrections by law.

3 SECTION 146. There is hereby appropriated to the Oklahoma State  
4 University Medical Authority Disbursing Fund from any monies not  
5 otherwise appropriated from the General Revenue Fund of the State  
6 Treasury for the Fiscal year ending June 30, 2012, the sum of Five  
7 Million Dollars (\$5,000,000.00) or so much thereof as may be  
8 necessary to perform the duties imposed upon the Oklahoma State  
9 University Medical Authority by law.

10 SECTION 147. TRANSFER Pursuant to the provisions of  
11 Enrolled Senate Bill No. 763 of the 1st Session of the 53rd Oklahoma  
12 Legislature, upon the effective date of this act, the Director of  
13 the Office of State Finance shall transfer all current and future  
14 liabilities, fund balances, encumbrances, obligations, and  
15 indebtedness associated with the Oklahoma Human Rights Commission to  
16 the Office of Civil Rights Enforcement within the Oklahoma Office of  
17 the Attorney General. Any monies accruing to or in the name of the  
18 Oklahoma Human Rights Commission on and after the effective date of  
19 this act, or any monies that accrue in any funds or accounts on and  
20 after the effective date of this act, in the name of the Oklahoma  
21 Human Rights Commission or maintained for the benefit of the  
22 Oklahoma Human Rights Commission, shall be deposited to the Office  
23 of Civil Rights Enforcement within the Oklahoma Office of the  
24 Attorney General.

1 SECTION 148. TRANSFER The Director of the Office of  
2 State Finance shall transfer the sum of Four Million Dollars  
3 (\$4,000,000.00) from the State Insurance Commissioner Revolving Fund  
4 ("200 FUND") to the Special Cash Fund of the State Treasury.

5 SECTION 149. TRANSFER The Director of the Office of  
6 State Finance shall transfer the sum of Fourteen Million Two Hundred  
7 Thousand Dollars (\$14,200,000.00) from the Oklahoma Tax Commission  
8 and Office of State Finance Joint Computer Enhancement Fund (210  
9 Fund) to the Special Cash Fund of the State Treasury.

10 SECTION 150. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 General Revenue Fund of the State Treasury for the fiscal year  
13 ending June 30, 2011, the sum of One Million Six Hundred Thousand  
14 Dollars (\$1,600,000.00) or so much thereof as may be necessary for  
15 transfer to the Teachers' Retirement System Dedicated Revenue  
16 Revolving Fund.

17 SECTION 151. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Special Cash Fund of the State Treasury, the sum of Twelve Million  
20 Fifty Thousand Dollars (\$12,050,000.00) to be transferred to the Ad  
21 Valorem Reimbursement Fund created pursuant to Section 193 of Title  
22 62 of the Oklahoma Statutes for the purpose of reimbursing counties  
23 for school districts that claim a loss of revenue due to a tax  
24

1 exemption granted pursuant to the provisions of Section 6B of  
2 Article X of the Oklahoma Constitution.

3 SECTION 152. TRANSFER The Director of State Finance  
4 shall transfer Thirteen Million Five Hundred Thousand Dollars  
5 (\$13,500,000.00) from the Office of the Attorney General's Evidence  
6 Fund (700 Fund), created by Section 19 of Title 74 of the Oklahoma  
7 Statutes to the Special Cash Fund of the State Treasury.

8 SECTION 153. There is hereby appropriated to the Oklahoma  
9 Health Care Authority from any monies not otherwise appropriated  
10 from the Special Cash Fund of the State Treasury, the sum of Eight  
11 Million Five Hundred Thousand Dollars (\$8,500,000.00) or so much  
12 thereof as may be necessary to perform the duties imposed upon the  
13 Oklahoma Health Care Authority by law.

14 SECTION 154. There is hereby appropriated to the Office of the  
15 Attorney General from any monies not otherwise appropriated from the  
16 Special Cash Fund of the State Treasury, the sum of Five Million  
17 Dollars (\$5,000,000.00) or so much thereof as may be necessary to  
18 perform the duties imposed upon the Office of the Attorney General  
19 by law for the prosecution and defense of claims related to water  
20 and water rights in Oklahoma.

21 SECTION 155. There is hereby appropriated to the Ethics  
22 Commission from any monies not otherwise appropriated from the  
23 Special Cash Fund of the State Treasury the sum of Sixty Thousand  
24

1 Dollars (\$60,000.00) or so much thereof as may be necessary to  
2 perform the duties imposed upon the Ethics Commission by law.

3 SECTION 156. There is hereby appropriated to the Department of  
4 Environmental Quality from any monies not otherwise appropriated  
5 from the Special Cash Fund of the State Treasury, the sum of Two  
6 Hundred Thousand Dollars (\$200,000.00) or so much thereof as may be  
7 necessary to perform the duties imposed upon the Department of  
8 Environmental Quality by law.

9 SECTION 157. TRANSFER The Director of State Finance  
10 shall transfer the sum of One Hundred Twenty Million Dollars  
11 (\$120,000,000.00) from the Cash-flow Reserve Fund of the Office of  
12 State Finance to the Special Cash Fund of the State Treasury.

13 SECTION 158. Sections 1 through 151 shall become effective July  
14 1, 2012.

15 SECTION 159. Section 157 shall become effective July 15, 2012.
