13 ~~BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE~~
14 ~~2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:~~

15 SECTION 1. The Secretary of State shall refer to the people for
16 their approval or rejection, as and in the manner provided by law,
17 the repeal of Sections 3 and 4 of Article XXV of the Constitution of
18 the State of Oklahoma which relate to the Oklahoma Public Welfare
19 Commission and the Director of Public Welfare.

20 SECTION 2. The Secretary of State shall refer to the people for
21 their approval or rejection, as and in the manner provided by law,
22 the following proposed amendment to the Constitution of the State of
23 Oklahoma by adding a new Section 6 to Article XXV thereof, to read
24 as follows:

1 Section 6. The Legislature shall have the authority and duty to
2 determine the composition and duties of the Human Services
3 Commission.

4 SECTION 3. The Ballot Title for the proposed Constitutional
5 amendment as set forth in SECTION 2 of this resolution shall be in
6 the following form:

9 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

10 This measure amends the State Constitution. It provides for the
11 repeal of Sections 3 and 4 of Article 25 which relate to the
12 Oklahoma Public Welfare Commission and the Director of Public
13 Welfare. This measure grants the Legislature the authority to
14 oversee the Human Services Commission.
