9 A Joint Resolution approving permanent rules of the
10 Oklahoma Uniform Building Code Commission; and
11 directing distribution.

13 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma
14 Statutes, any rule which establishes or increases fees or any rule
15 by an agency, board, or commission created by or that receives its
16 authority from Title 59 of the Oklahoma Statutes shall require
17 approval by the Legislature by joint resolution. If the Legislature
18 fails to approve the rule on or before the last day of the
19 legislative session, the rule shall be deemed disapproved; and

20 WHEREAS, the Oklahoma Uniform Building Code Commission cites the
21 following authority for the rules adopted on March 20, 2012: Section
22 1000.24 of Title 59 of the Oklahoma Statutes; and

23 WHEREAS, the permanent rules adopted by the Commission on March
24 20, 2012, reflect the intent of the Oklahoma Legislature.

1 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
2 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

3 SECTION 1. The Legislature hereby approves the following
4 permanent rules which were adopted by the Oklahoma Uniform Building
5 Code Commission on March 20, 2012: OAC 748:1-1-2, 748:1-1-4, 748:3-
