9 A Joint Resolution approving permanent rules of the
10 Oklahoma Construction Industries Board; and directing
11 distribution.

13 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma
14 Statutes, any rule which establishes or increases fees or any rule
15 by an agency, board, or commission created by or that receives its
16 authority from Title 59 of the Oklahoma Statutes shall require
17 approval by the Legislature by joint resolution. If the Legislature
18 fails to approve the rule on or before the last day of the
19 legislative session, the rule shall be deemed disapproved; and

20 WHEREAS, the Oklahoma Construction Industries Board cites the
21 following authority for the rules adopted on February 8, 2012:
22 Sections 1002, 1000.4, 1000.5, 1032, 1850.3 and 858-627 of Title 59
23 of the Oklahoma Statutes; and

1 WHEREAS, the permanent rules adopted by the Board on February 8,
2 2012, reflect the intent of the Oklahoma Legislature.

3 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
4 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

5 SECTION 1. The Legislature hereby approves the following
6 permanent rules which were adopted by the Oklahoma Construction
7 Industries Board on February 8, 2012: OAC 158:1-3-1, 158:30-1-4,
8 158:30-3-2, 158:30-9-1, 158:30-9-4, 158:40-9-3, 158:40-9-4, 158:50-
9 1-2, 158:50-1-3, 158:50-1-4, 158:50-5-1, 158:50-5-2, 158:50-9-1,
10 158:50-9-2, 158:50-9-7, 158:60-1-2, 158:60-5-1, 158:60-5-2, 158:60-
11 5-3, 158:60-5-4, 158:60-5-5, 158:70-1-2, 158:70-1-3, 158:70-9-1,
12 158:70-9-5, 158:70-9-6, and 158:70-11-3.

13 SECTION 2. The Secretary of State is hereby directed to
14 distribute copies of this resolution to the Governor, the Oklahoma
15 Construction Industries Board, and the editor of "The Oklahoma
16 Register".
