9 AS INTRODUCED

10 An Act relating to the Oklahoma State Regents for
11 Higher Education; making appropriations; authorizing
12 expenditures of certain funds; stating purpose;
13 requiring budgeting of certain funds in certain
14 years; providing lapse dates; requiring certain
15 budget procedures; prohibiting certain budget
16 procedures; and providing an effective date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. There is hereby appropriated to the Oklahoma State
19 Regents for Higher Education from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2012, the sum of
22 _____ Dollars (\$0.00) or so much thereof as may be
23 necessary for allocation by the Oklahoma State Regents for Higher
24 Education pursuant to the provisions of Article XIII-A of the

1 Oklahoma Constitution for the education and general operating
2 budgets of the institutions and for other programs, construction,
3 renovations or repairs administered by the Oklahoma State Regents
4 for Higher Education.

5 SECTION 2. The Oklahoma State Regents for Higher Education are
6 hereby authorized to expend during the fiscal year ending June 30,
7 2012, the sum of _____ Dollars (\$0.00) from the Higher
8 Education Capital Revolving Fund of the State Treasury for
9 allocation by the Oklahoma State Regents for Higher Education
10 pursuant to the provisions of Article XIII-A of the Oklahoma
11 Constitution for the education and general operating budgets of the
12 institutions and for other programs, construction, renovations or
13 repairs administered by the Oklahoma State Regents for Higher
14 Education.

15 SECTION 3. The Oklahoma State Regents for Higher Education are
16 hereby authorized to expend during the fiscal year ending June 30,
17 2012, the sum of _____ Dollars (\$0.00) from the
18 Oklahoma Tuition Scholarship Revolving Fund of the State Treasury
19 for allocation by the Oklahoma State Regents for Higher Education
20 pursuant to the provisions of Article XIII-A of the Oklahoma
21 Constitution for the education and general operating budgets of the
22 institutions and for other programs, construction, renovations or
23 repairs administered by the Oklahoma State Regents for Higher
24 Education.

1 SECTION 4. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the Special Cash Fund of the State Treasury, the
4 sum of _____ Dollars (\$0.00) or so much thereof as
5 may be necessary for the education and general operating budgets of
6 the institutions and for other programs, construction, renovations
7 or repairs administered by the Oklahoma State Regents for Higher
8 Education.

9 SECTION 5. There is hereby appropriated to the Oklahoma State
10 Regents for Higher Education from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2012, the sum of
13 _____ Dollars (\$0.00) or so much thereof as may be
14 necessary for expenditures for concurrent enrollment pursuant to
15 Section 628.13 of Title 70 of the Oklahoma Statutes.

16 SECTION 6. There is hereby appropriated to the Oklahoma State
17 Regents for Higher Education from any monies not otherwise
18 appropriated from the Oklahoma Education Lottery Trust Fund of the
19 State Treasury for the fiscal year ending June 30, 2012, the sum of
20 _____ Dollars (\$0.00) pursuant to paragraph 2 of
21 subsection C of Section 713 of Title 3A of the Oklahoma Statutes for
22 allocation by the Oklahoma State Regents for Higher Education
23 pursuant to provisions of Article XIII-A of the Oklahoma
24 Constitution for construction, renovations or repairs administered

1 by the Oklahoma State Regents for Higher Education or for any other
2 purpose authorized by paragraph 2 of subsection C of Section 713 of
3 Title 3A of the Oklahoma Statutes.

4 SECTION 7. There is hereby appropriated to the Oklahoma State
5 Regents for Higher Education from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2012, the sum of
8 _____ Dollars (\$0.00) or so much thereof as may be
9 necessary for the general operating budget of the Administrative
10 Offices of the Oklahoma State Regents for Higher Education.

11 SECTION 8. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the General Revenue Fund of the State Treasury for
14 the fiscal year ending June 30, 2012, the sum of
15 _____ Dollars (\$0.00) or so much thereof as may be
16 necessary for the Office of Accountability to perform the duties
17 imposed upon the Office of Accountability by law.

18 SECTION 9. Appropriations made by this act, not including
19 appropriations made for capital outlay purposes, may be budgeted for
20 the fiscal year ending June 30, 2012 (hereafter FY-12) or may be
21 budgeted for the fiscal year ending June 30, 2013 (hereafter FY-13).
22 Funds budgeted for FY-12 may be encumbered only through June 30,
23 2012, and must be expended by November 15, 2012. Any funds
24 remaining after November 15, 2012, and not budgeted for FY-13, shall

1 lapse to the credit of the proper fund for the then current fiscal
2 year. Funds budgeted for FY-13 may be encumbered only through June
3 30, 2013. Any funds remaining after November 15, 2013, shall lapse
4 to the credit of the proper fund for the then current fiscal year.
5 These appropriations may not be budgeted in both fiscal years
6 simultaneously. Funds budgeted in FY-12, and not required to pay
7 obligations for that fiscal year, may be budgeted for FY-13, after
8 the agency to which the funds have been appropriated has prepared
9 and submitted a budget work program revision removing these funds
10 from the FY-12 budget work program and after such revision has been
11 approved by the Office of State Finance.

12 SECTION 10. This act shall become effective September 1, 2011.
