6 AS INTRODUCED

7 An Act relating to state government; amending 74 O.S.
8 2011, Section 3903, which relates to the termination
9 of certain statutory entities; re-creating certain
10 entities; and modifying termination date.

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. AMENDATORY 74 O.S. 2011, Section 3903, is
13 amended to read as follows:

14 Section 3903. The following statutory entities and their
15 successors shall be terminated on July 1, ~~2012~~ 2016, and all powers,
16 duties and functions shall be abolished one (1) year thereafter:
