13 fund; allowing certain donations; providing limit of
14 donation; specifying certain donors shall not affect

16 for codification; and providing an effective date.

1 person is on the list. The Developmental Disabilities Services
2 Division of the Department of Human Services shall not move a person
3 whose income or assets have increased no more than One Thousand
4 Dollars (\$1,000.00) for each year the person is on the list to a
5 lower position on the statewide waiver request waiting list.

6 B. Nonprofit organizations in the state seeking to participate
7 as a granting agency may create a separate general fund into which
8 private individuals, businesses, corporations and other nonprofit
9 organizations, to include foundations, may donate cash and property
10 to be dispensed through the granting process by the selection
11 committee of the board of the nonprofit organization. The granting
12 agency donations to those registered on the statewide waiver request
13 list, not to exceed One Thousand Dollars (\$1,000.00), in cash and
14 unlimited in-kind, with accounting documentation available for
15 Medicaid, Medicare, Supplemental Nutrition Assistance Program and
16 any other program in which income is an eligibility consideration,
17 shall not affect the donation recipient's placement on the statewide
18 waiver request waiting list.

19 SECTION 2. This act shall become effective November 1, 2012.
