HOUSE JOINT
RESOLUTION 1006

AS INTRODUCED

A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection a proposed amendment to the Constitution of the State of Oklahoma by adding a new Section 100 to Article X; providing for the Public Retirement System Improvement Act of 2011; providing ballot title; and directing filing.

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE 1ST SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for their approval or rejection, as and in the manner provided by law, the following proposed amendment to the Constitution of the State of Oklahoma by adding a new Section 100 to Article X thereof, to read as follows:

This section shall be known and may be cited as the "Public Retirement System Improvement Act of 2011".

1 SECTION 2. The Ballot Title for the proposed Constitutional
2 amendment as set forth in SECTION 1 of this resolution shall be in

7 This measure would amend the Oklahoma Constitution. It would
8 add a new Section 100 to Article 10. It would be known as the
9 Public Retirement System Improvement Act of 2011.
