2 government. For purposes of this section, the real and personal
3 property to which the exemption is applicable shall be determined by
4 reference to federal law, including any administrative rule of a
5 federal agency used to determine the type of property which
6 qualifies for any grant, loan, tax incentive or other form of
7 assistance from the United States government.

8 SECTION 2. The Ballot Title for the proposed Constitutional
9 amendment as set forth in SECTION 1 of this resolution shall be in
10 the following form:

13 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

14 This measure would amend the State Constitution. It would add a
15 new section to the Constitution. The section deals with tax.
16 It would exempt some property from being taxed. It would apply
17 to some property used in single-family homes. The property
18 would have to be used for alternative energy sources. The
19 property would also have to be eligible for certain aid from the
20 federal government. This measure would apply to both real and
21 personal property.
