6 AS INTRODUCED

7 A Joint Resolution approving permanent rules of the
8 Board of Governors of the Licensed Architects,
9 Landscape Architects and Registered Interior
10 Designers of Oklahoma; and directing distribution.

12 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma
13 Statutes, any rule which establishes or increases fees or any rule
14 by an agency, board, or commission created by or that receives its
15 authority from Title 59 of the Oklahoma Statutes shall require
16 approval by the Legislature by joint resolution. If the Legislature
17 fails to approve the rule on or before the last day of the
18 legislative session, the rule shall be deemed disapproved; and

19 WHEREAS, pursuant to Section 46.7 of Title 59 of the Oklahoma
20 Statutes, the Board of Governors of the Licensed Architects,
21 Landscape Architects and Registered Interior Designers of Oklahoma
22 shall adopt the rules and regulations for the implementation of the
23 provisions of the State Architectural and Registered Interior
24 Designers Act; and

1 WHEREAS, the permanent rules adopted by the Board on February
2 17, 2012, reflect the intent of the Oklahoma Legislature.

3 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
4 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

5 SECTION 1. The Legislature hereby approves the following
6 permanent rules, which were adopted by the Board on February 17,
7 2012: OAC 55:10-1-3, 55:10-3-3, 55:10-3-6, 55:10-3-11, 55:10-3-13,
