7 AS INTRODUCED

8 A Joint Resolution approving permanent rules of the  
9 Oklahoma Real Estate Commission; and directing  
10 distribution.

12 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma  
13 Statutes, any rule which establishes or increases fees or any rule  
14 by an agency, board, or commission created by or that receives its  
15 authority from Title 59 of the Oklahoma Statutes shall require  
16 approval by the Legislature by joint resolution. If the Legislature  
17 fails to approve the rule on or before the last day of the  
18 legislative session, the rule shall be deemed disapproved; and

19 WHEREAS, pursuant to Section 858-208 of Title 59 of the Oklahoma  
20 Statutes, the Oklahoma Real Estate Commission shall promulgate  
21 rules, prescribe administrative fees by rule, and make orders as it  
22 may deem necessary or expedient in the performance of its duties;

1       WHEREAS, the permanent rules adopted by the Oklahoma Real Estate  
2 Commission on March 14, 2012, reflect the intent of the Oklahoma  
3 Legislature.

4       NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES  
5 AND THE SENATE OF THE 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

6       SECTION 1. The Legislature hereby approves the following  
7 permanent rules, which were adopted by the Oklahoma Real Estate  
8 Commission on March 14, 2012: OAC 605:10-1-2, 605:10-1-3, 605:10-3-  
9 5, 605:10-3-7, 605:10-5-1, 605:10-5-1.1, 605:10-5-2, 605:10-7-2,  
10 605:10-7-3, 605:10-7-4, 605:10-7-7, 605:10-7-8, 605:10-7-8.1,  
11 605:10-7-8.2, 605:10-7-8.3, 605:10-7-8.4, 605:10-9-1, 605:10-9-4,  
12 605:10-11-2, 605:10-11-3, 605:10-13-1, 605:10-15-3, 605:10-17-4,  
13 605:10-17-6 and Appendix A.

14       SECTION 2. The Secretary of State is directed to distribute  
15 copies of this resolution to the Governor, the Oklahoma Real Estate  
16 Commission, and the editor of "The Oklahoma Register".
