5 AS INTRODUCED

6 An Act relating to technology center school  
7 districts; amending 70 O.S. 2011, Section 1-118.1,  
8 which relates to building fund of technology center  
9 school districts; allowing additional uses of certain  
funds; providing an effective date; and declaring an  
emergency.

10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 70 O.S. 2011, Section 1-118.1, is  
12 amended to read as follows:

13 Section 1-118.1. The building fund of any technology center  
14 school district shall consist of all monies derived from the  
15 proceeds of a building fund levy ~~of~~ not to exceed five (5) mills in  
16 any year, voted by the people of a school district pursuant to the  
17 provisions of ~~Article X~~, Section 10~~7~~, of Article X of the Oklahoma  
18 Constitution, monies appropriated by the state for the purpose of  
19 capital expenditures or projects, and monies donated to a school  
20 district for the purpose of capital projects or improvements and may  
21 be used for purchasing, providing, erecting, remodeling, repairing  
22 or maintaining any of the following: school buildings, ~~for~~  
23 ~~purchasing~~ furniture, computer systems and equipment and computer,  
24 software for instructional and noninstructional purposes, ~~for~~

1 ~~repairing and maintaining computer systems and equipment, for paying~~  
2 energy and utility costs, ~~for purchasing~~ telecommunications  
3 utilities and services, ~~for paying~~ fire and casualty insurance  
4 premiums for school facilities, ~~for purchasing security systems, for~~  
5 ~~paying salaries of security personnel,~~ student transportation,  
6 grounds maintenance including parking lots and sidewalks,  
7 instructional and maintenance equipment, or for one or more, or all,  
8 of ~~such~~ these purposes. Proceeds of ~~such~~ the levies shall not be  
9 required to be used during the year for which a levy is made but may  
10 accumulate from year to year until adequate for the purposes  
11 intended. The building fund ~~hereinabove~~ defined in this section is  
12 hereby declared to be a current expense fund, but shall not be  
13 considered a part of the general operating fund. No monies derived  
14 from the proceeds of the school levies made pursuant to the  
15 provisions of ~~Article X,~~ Section 9B of Article X of the Oklahoma  
16 Constitution may be placed in the building fund provided by this  
17 section.

18 SECTION 2. This act shall become effective July 1, 2012.

19 SECTION 3. It being immediately necessary for the preservation  
20 of the public peace, health and safety, an emergency is hereby  
21 declared to exist, by reason whereof this act shall take effect and  
22 be in full force from and after its passage and approval.
