6 AS INTRODUCED

7 An Act relating to the Oklahoma Self-Defense Act;
8 amending 21 O.S. 2011, Section 1290.26, which relates
9 to reciprocal agreement authority; adding non-
10 permitting carry states that Oklahoma shall
11 reciprocate under certain circumstances; requiring
12 compliance with the Oklahoma Self-Defense Act;
13 requiring certain proof of residency; requiring the
14 Department of Public Safety to maintain certain list
15 of states; and providing an effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA

17 SECTION 1. AMENDATORY 21 O.S. 2011, Section 1290.26, is
18 amended to read as follows:

19 Section 1290.26.

20 RECIPROCAL AGREEMENT AUTHORITY

21 The State of Oklahoma hereby recognizes any valid concealed
22 carry weapons permit or license issued by another state, or if the
23 state is a nonpermitting carry state, this state shall reciprocate
24 under the permitting law of that state.

25 A. Any person entering this state in possession of a firearm
26 authorized for concealed carry upon the authority and license of

1 another state, is authorized to continue to carry a concealed
2 firearm and license in this state; provided the license from the
3 other state remains valid. The firearm must be carried fully
4 concealed from detection and view, and upon coming in contact with
5 any peace officer of this state, the person must disclose the fact
6 that he or she is in possession of a concealed firearm pursuant to a
7 valid concealed carry weapons permit or license issued in another
8 state.

9 B. Any person entering this state in possession of a firearm
10 authorized for concealed carry upon the authority of a state that is
11 a nonpermitted carry state and the person is in compliance with the
12 Oklahoma Self-Defense Act, the person is authorized to carry a
13 concealed firearm in this state. The firearm must be carried fully
14 concealed from detection and view, and upon coming in contact with
15 any peace officer of this state, the person must disclose the fact
16 that he or she is in possession of a concealed firearm pursuant to
17 the nonpermitting laws of the state in which he or she is a legal
18 resident. The person shall present proper identification by a valid
19 photo ID as proof that he or she is a legal resident in such a non-
20 permitting state. The Department of Public Safety shall keep a
21 current list of non-permitting states for law enforcement officers
22 to confirm that a state is nonpermitting.

23 C. Any person who is twenty-one (21) years of age or older
24 having a valid firearm license from another state may apply for a

1 concealed handgun license in this state immediately upon
2 establishing a residence in this state.

3 SECTION 2. This act shall become effective November 1, 2012.
